Under Rule 11, Article 16 (c) of the Implementing Rules and Regulations of Republic Act No. 10625, the National Statistician shall provide overall direction in the implementation of the Civil Registry Law and related issuances and exercise technical supervision over the civil registrars as Civil Registrar General.

In February 2022, the Philippine Statistics Authority (PSA) launched the "PhilSys Birth Registration Assistance Project" [now Birth Registration Assistance Project (BRAP)] in the country to ensure that all births of Filipinos are registered in the Local Civil Registry Offices and that they will be enrolled with the Philippine Identification System (PhilSys). The project aims to increase the level of civil registration especially in marginalized communities such as those belonging to the Indigenous Peoples, Muslim Filipinos, and the poorest sector in the country and ensure that they have their Philippine Identification (PhilID) issued which is a gateway for them to claim their social benefits and legal identity.

To guide the PSA on the fees and charges imposed and collected by the respective Local Government Units (LGUs) related to civil registration and for the smooth implementation of the above-mentioned project, all City/Municipal Civil Registrars (C/MCRs) and those designated as
