APPROVING THE CONDUCT OF BARANGAY CENSUS DURING OFF-CENSUS YEAR IN BARANGAY NAZARETH, CAGAYAN DE ORO CITY

WHEREAS, Section 6 of Republic Act No. 10625, otherwise known as the Philippine Statistical Act of 2013, mandates the Philippine Statistics Authority (PSA) to prepare and conduct periodic censuses on population, housing, agriculture, fisheries, business, industry, and other sectors of the economy;

WHEREAS, Section 6 (e) of Executive Order No. 135 series of 1993, entitled Establishment of Well-Coordinated Local Level Statistical System, provides that the smallest geographic area for which a certification on population size may be issued, will be the barangay for census population counts, and the city or municipality for intercensal estimates. If a Local Government Unit wants to conduct its own population census, during off-census years, approval must be sought from the National Statistical Coordination Board (NSCB), and the conduct must be under the technical supervision of the National Statistics Office (NSO), from planning to data processing;

WHEREAS, Section 28 of RA 10625 mentions the Abolition of Existing Government Bodies. The NSO, the Bureau of Agricultural Statistics of the Department of Agriculture, the Bureau of Labor and Employment Statistics of the Department of Labor and Employment, and the NSCB shall be abolished, and their appropriations, records, properties, and personnel shall be transferred to the PSA;

WHEREAS, on 23 January 2024, Barangay Nazareth, Cagayan de Oro City formally requested approval from the PSA to conduct a census during off-census year, to validate the actual population count of the barangay;

WHEREAS, the PSA has endorsed to the PSA Board, the approval of the conduct of a Barangay Census during off-census year, of Barangay Nazareth, Cagayan de Oro City;




