**APPROVING THE APPOINTMENT OF THE PHILIPPINE SOCIAL
SCIENCE COUNCIL (PSSC)
AS THE PRIVATE SECTOR REPRESENTATIVE TO THE
PHILIPPINE STATISTICS AUTHORITY BOARD
EFFECTIVE 22 FEBRUARY 2022 TO 21 FEBRUARY 2025**

WHEREAS, the Philippine Statistics Authority (PSA) was established through Republic Act No. 10625 to effect necessary and proper changes in the organizational and functional structure of the Philippine Statistical System (PSS);

WHEREAS, Section 05 of RA 10625 states that the PSA shall be governed by a Board as the highest policy-making body on statistical matters;

WHEREAS, Section 07 of RA 10625 stipulates that the Board shall be composed of the following: the NEDA Director-General, as Chairperson; the Secretary of the Department of Budget and Management (DBM) or the duly designated Undersecretary, as Vice Chairperson; National Statistician; one (1) representative each from the other departments in the national government; a representative of BSP; the Executive Director of the PSRTI; a representative of the Philippine Statistical Association; a representative from the GOCCs; a representative each from the Union of Local Authorities of the Philippines (ULAP) and the private sector to be appointed by the Chairperson of the PSA Boars for the term of three (3) years, with reappointment, from a list of nominees submitted by the other members of the Board;

WHEREAS, the Private Sector representative shall be appointed by the PSA Board Chairperson and shall have the three-year term with possible reappointment for another three years;

WHEREAS, to complete the composition of the PSA Board and to further enhance the partnership between the private sector and the government in the generation of official statistics, the PSA Board hereby approves the designation of PSSC as the representative of the private sector in the PSA Board;

NOW, THEREFORE, BE IT RESOLVED, that the Board approves the appointment of PSSC as the representative of the Private Sector to the PSA Board effective 22 February 2022 to 21 February 2025;

RESOLVED FURTHER that copies of this Resolution be forwarded to PSSC to designate their Permanent and Alternate representatives to the PSA Board.
