The Philippine Statistics Authority (PSA) now accepts registration of participants to the **14th National Convention on Statistics (NCS)** to be held on **01-03 October 2019** at the Crowne Plaza Manila Galleria in Ortigas Ave. cor. Asian Development Bank Ave., Quezon City.

About the Convention

The NCS, a triennial activity, is the country's biggest gathering of statisticians, statistical practitioners, academicians, researchers, students, and media, both from the government and private sector. Through the years, the NCS has provided a forum for exchanging ideas and experiences in the field of statistics and for discussing recent statistical developments and prevailing issues and problems of the Philippine Statistical System (PSS). The NCS has also created new and strengthened partnerships among government agencies, private sector, media, academia, international organizations, and development partners.

14th NCS Theme

The 14th NCS will carry the theme **"Data Innovation: Key to a Better Nation."** The theme signifies the importance of innovation in the provision of quality statistics which will help policymakers design responsive and evidence-based plans and programs towards a better nation.

This year, the 14th NCS will coincide with the opening of the 30th National Statistics Month (NSM) celebration in October 2019. The 14th NCS will feature the Statistical Information Management Exhibition (SIMEx), a commercial exhibition of the latest software, hardware, and other products on statistical information management and dissemination.
