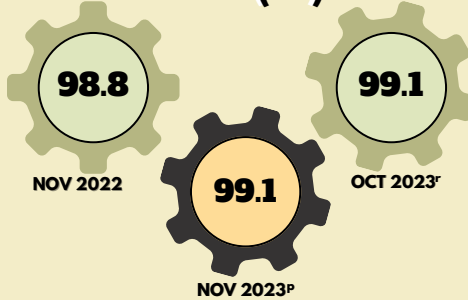


## PPI for Total Manufacturing

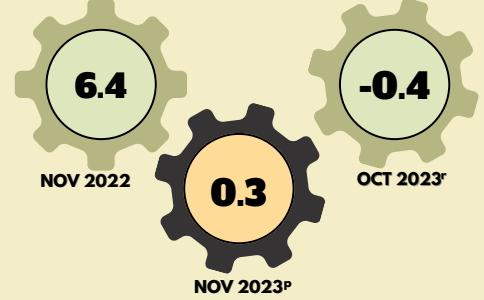
### PPI

is a measure of change in the prices of products or commodities produced by domestic manufacturers and sold at farmgate prices to wholesalers/other consumers in the domestic market.

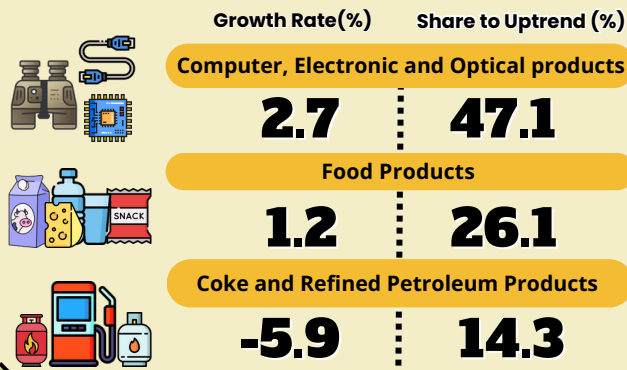
### PPI (%)



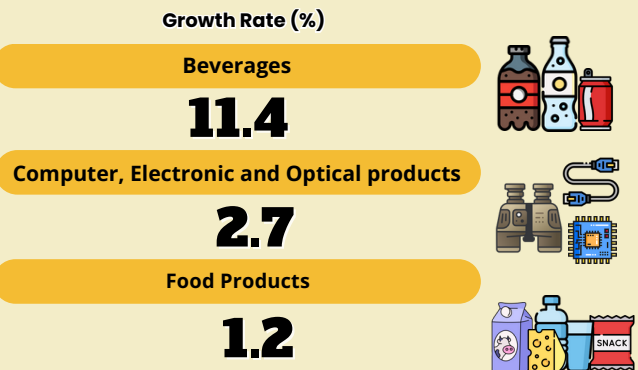
### Annual Growth Rate (%)



### Main Sources of Annual Increase

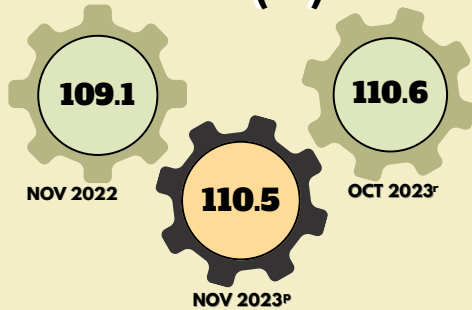


### Major Contributors to the Annual Growth Rate

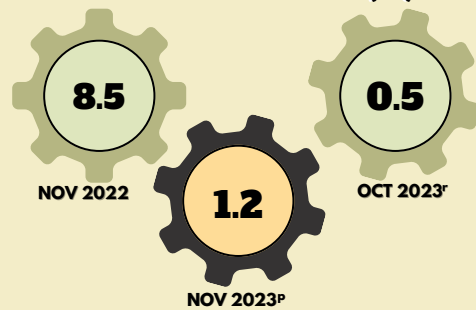

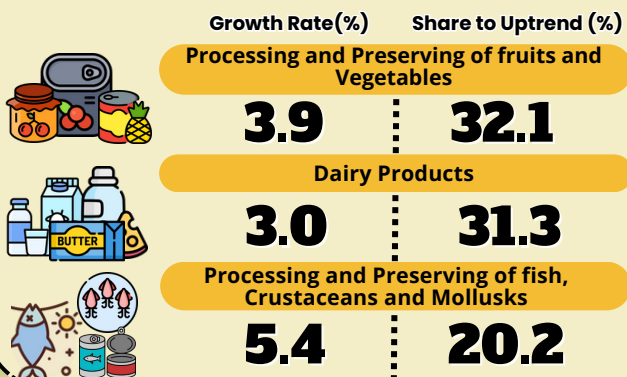
