WHEREAS, the Opening of the Bids for the Procurement of Supply, Delivery and Installation of ICT Equipment and Hardware Security Module Device for Philsys Registry Office (PRO) was conducted on 06 October 2020;

WHEREAS, the above-mentioned procurement is divided into two (2) lots, namely:

Lot/s	Description

WHEREAS, on 06 October 2020, the BAC issued Resolution No. 20-10-02 declaring failure of bidding for Lot 1 of the above-mentioned procurement since no bidder/s have paid for nor submitted a bidding document for the same Lot;

WHEREAS, on 08 October 2020, the BAC issued Resolution No. 20-10-07 declaring the bid of Advance Solutions Inc. (ASI) as the Single Calculated Bid (SCB) for Lot 2 of the Procurement of Supply, Delivery and Installation of ICT Equipment and Hardware Security Module Device for Philsys Registry Office (PRO) and recommended the conduct of post-qualification for the same bidder;

WHEREAS, the post-qualification report was submitted to the Bids and Awards Committee through its Secretariat on 16 October 2020;
