HIGHLIGHTS

- OIC-DNS Minerva Eloisa P. Esquivias welcomed the attendees for the Pre-bid Conference for the Procurement of Services of Registration Agencies for PhilSys (Outsourcing of PhilSys Registration) in NCR and Region IV-A.
- The rationale behind the procurement at hand is to expedite the mass registration for the National ID especially in high population density areas such as the NCR and Region IV-A. Thus, the PSA opted to procure a registration agency for those aforementioned regions.
- The Approved Budget for the Contract is Php 2,347,990,000.00
- The procurement consists of two (2) lots:

- The Chairperson reminded the bidder as to why this activity was conducted via the Zoom platform- that is, due to the restrictions brought by the General Community Quarantine (GCQ)

- The BAC informed the bidder that the pre-bid conference is an initial forum where PSA presents the projects to be bid. The PSA will discuss different aspects of the procurement at hand, the ground rules that will govern the procurement and the technical and financial components of the contract subject of bidding.
- The Chairperson noted that any statement made at this Pre-bid Conference will not modify the terms of the bidding documents, unless such statement is specifically identified in writing as an amendment to the documents and issued as a supplemental/bid bulletin or some clarifications that may be responded to as Question and Answer.
- The Chairperson instructed the Secretariat to proceed to the highlights for this Pre-Bid Conference.
- The bidder was informed that PSA already posted a supplemental bid bulletin which amends the said bidding documents on 23 December 2020.
