### Objectives of RSBSA

- To be used as the basis for developing programs and policies for the agriculture and fishery sectors
- To serve as a targeting mechanism for the identification of the rural poor

Starting 2014, the RSBSA is being used as the basis for identifying those in the agricultural sector that can avail of 100% insurance subsidy from the Philippine Crop Insurance Corporation.



### Creation of the RSBSA

#### **Agencies involved**

- DBM: main project implementor and custodian
- NSO (now PSA): developed the registration forms, manuals, materials and computerized database system, conduct of training and data processing
- DA and DAR: consultants in technical aspects of the registration activity
- DILG (with LGUs): data collection
  - Punong barangay and barangay secretaries: main implementors
  - C/MAO and C/MPDO: administrative supervision of survey in all barangays

The registration activity was conducted in two phases:

- Phase 1 (January 2012): 20 provinces
- Phase 2 (September to November 2012): 55 provinces
- RSBSA excludes NCR and ARMM provinces

## Issues on the RSBSA (version 1)

- Exclusion and leakage
  - There are legitimate agricultural producers that are excluded from the list
  - Persons in the list that should not be in the list (not a farmer, laborer and/or fisherfolk)
- The registry is difficult to link with other databases
  - Based on matching exercise (fuzzy matching) with PCIC lists of insured farmers, there are issues on spelling (e.g. transposition of vowels), completeness of name (e.g. no middle names, nicknames), and duplication



## Issues on the RSBSA (version 1)

- No validation of the list happened
- Total arable/agricultural land might be understated in the RSBSA
- The operational definition of farmer is not clear; and concerned agencies might need to fine-tune the list according to their own defined program objectives
  - There were instances that the farm owner and the farm "katiwala" are both listed in the RSBSA
  - Not all the agricultural producers in the list have "insurable interest", based on non-crop agricultural assets, minimum land hectarage to be insurable, minimum number of livestock to be insured



## RSBSA version 1.1 was produced to update the 2012 RSBSA

- A list of agricultural producers from five government agencies (i.e. DAR, PCIC, NIA, BFAR, DA) were submitted to DBM for consideration in adding to the 2012 RSBSA (version 1)
- DBM consolidated the names of agricultural producers from these list and formed the RSBSA version 1.1

## For the provision of free agricultural insurance, PCIC analyzed the two versions of the RSBSA

- Using the PCIC Automated Business Systems, the list were adjusted to account for names of agricultural producers listed in both RSBSA versions (duplication)
- After adjustments for name duplication, the number of RSBSA farmers and fisherfolk was reduced to 10,915,180:
  - Farmers: 5,481,428
  - Farm laborers: 4,069,433
  - Fisherfolk: 1,364,319
- Given that adjustments are made by an automated system, check for duplication may not be accurate and may lead to exclusion of eligible farmers



### Recommendations

#### **Validation**

- The agricultural producers/workers in the RSBSA must be validated in the field by the appropriate agency/ies---LGU (PAO/MAO), NIA via Irrigators' Associations. There must be only one validated list.
- The registry needs to be updated regularly— every 3 years perhaps or could be updated using the CBMS data.
- The definition of farmer, farm worker and fisherfolk must be reviewed vis-à-vis how the registry would be actually used by the different government agencies



### Recommendations

### Use as targeting tool

 There must be more specific guidelines before the RSBSA can be used for subsidy targeting to guide program implementers who to prioritize.

#### Use as input in budget estimation

 The RSBSA list can be utilized in the estimation of budgetary requirements of government programs for farmers and fisherfolk.
