Focus on standards

Challenges as documented of surveys by UN Statistics Division, World Bank and PARIS21 in 2018 and 2021:

- national statistics offices have inadequate capacity(resources and technical knowledge) to comply with international standards including classifications
- countries identified the implementation of statistical standards in specific domains (65%) and new concepts and methods for measuring sustainable development(54%) among the priority areas for the modernization of the national statistical system
- most low-income and lower-middle-income countries chose coordination among members of the system (97%) and data quality assurance (91%) to invest in



The case of the Philippines

- Philippine Statistical Act of 2013 as legal basis
- Regular Development and Release of Philippine Statistical Development Program
- Active Interagency Committees on Statistical Concerns Coordinated by PSA
- Active Research by the statistics community with PSRTI as the research arm of the PSS and PSAI as the professional society
