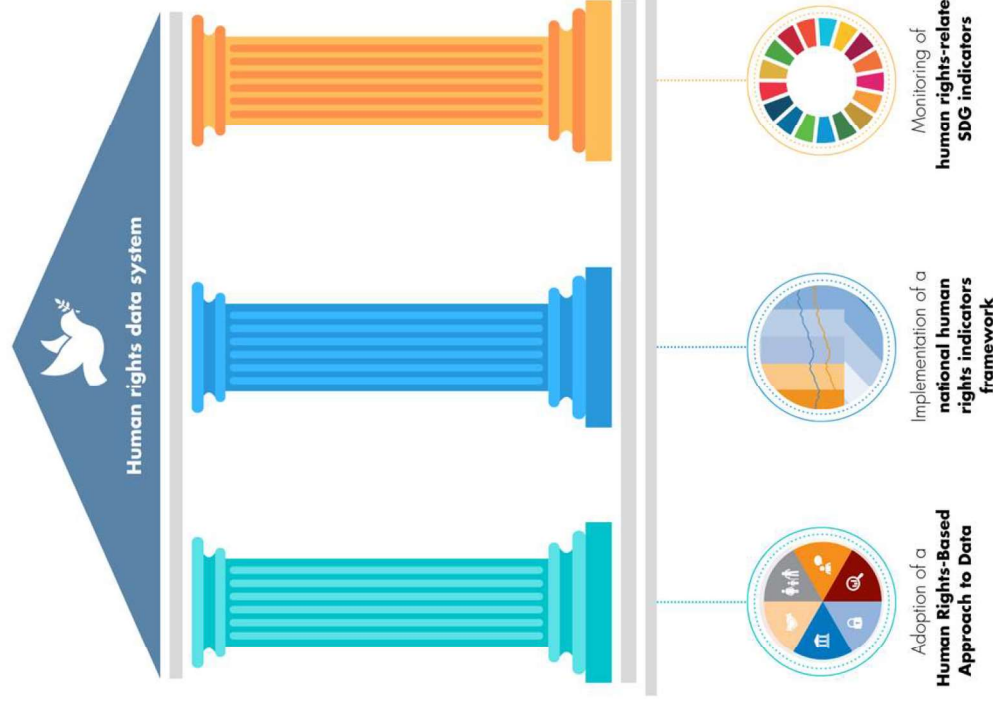

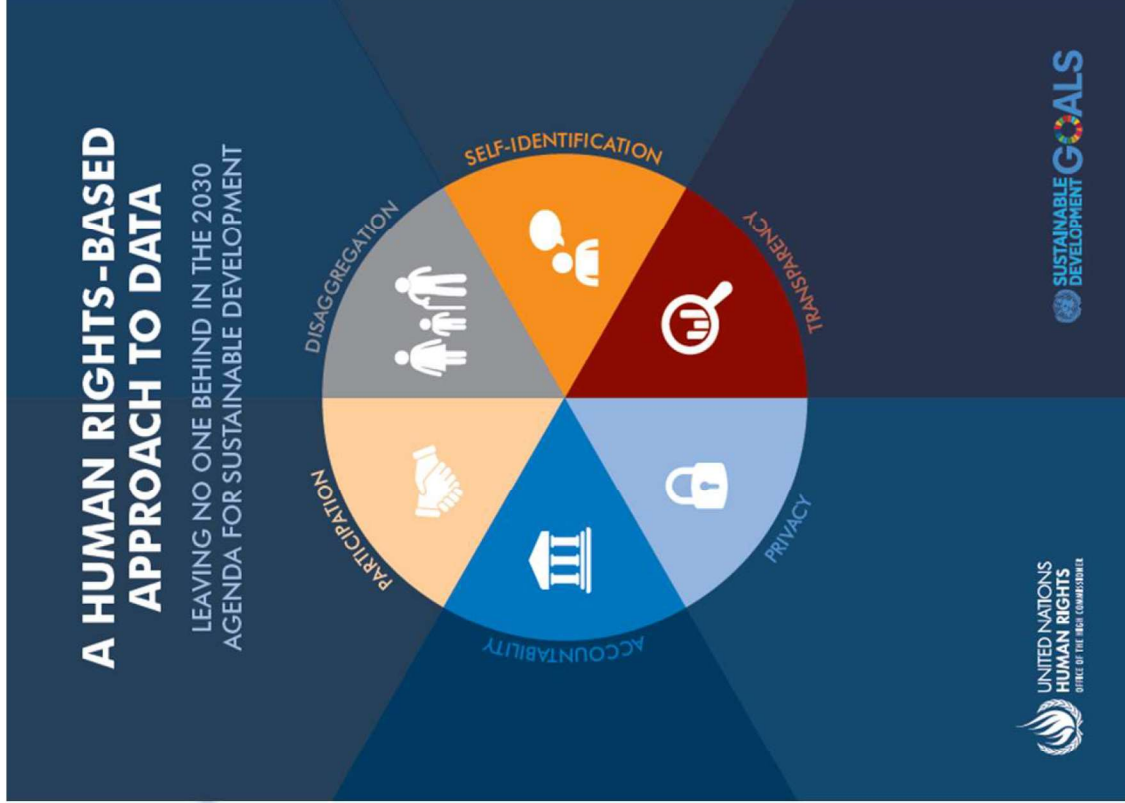

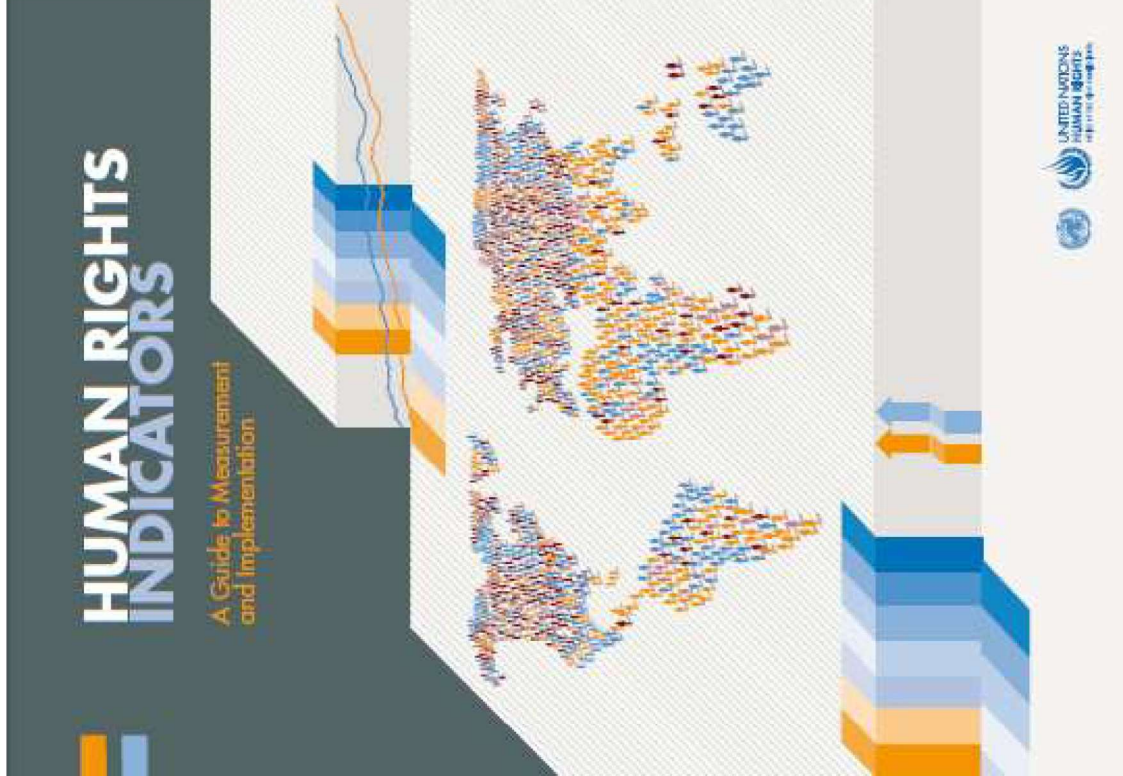
- 2030 Agenda: **data revolution** and **data disaggregation**

Specific information on the state of an event, activity or an outcome that can be **related to human rights** norms; that addresses and **reflects the human rights concerns** and principles; and that is **used to assess and monitor** promotion and protection of human rights.

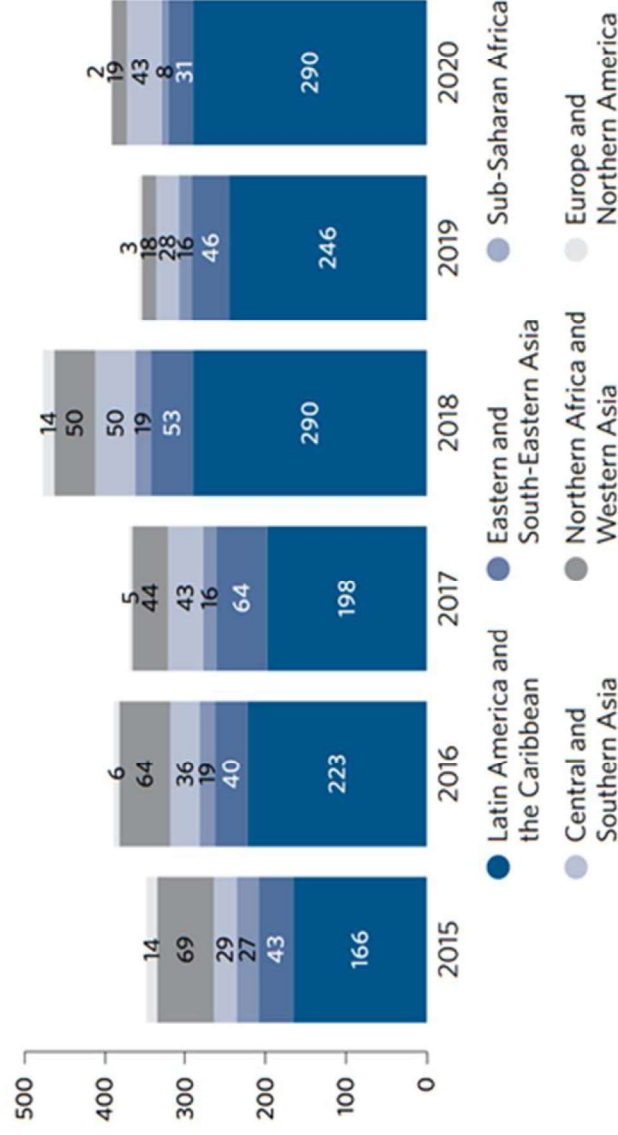

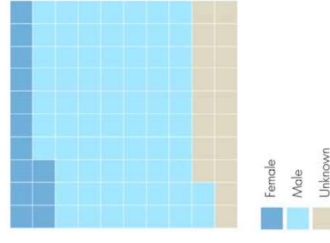

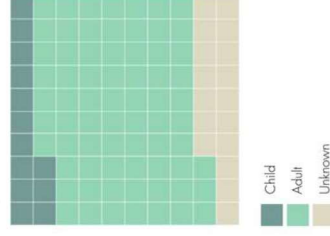
Conflict-related deaths (disaggregation)

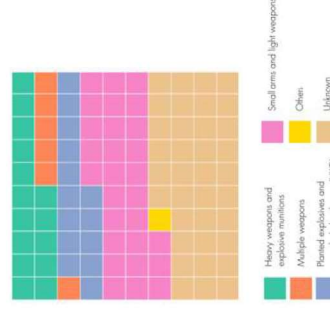
Sex

This figure may vary from other UN civilian casualty figures due to the methodology used that build on UN casualty data while integrating new data sources. 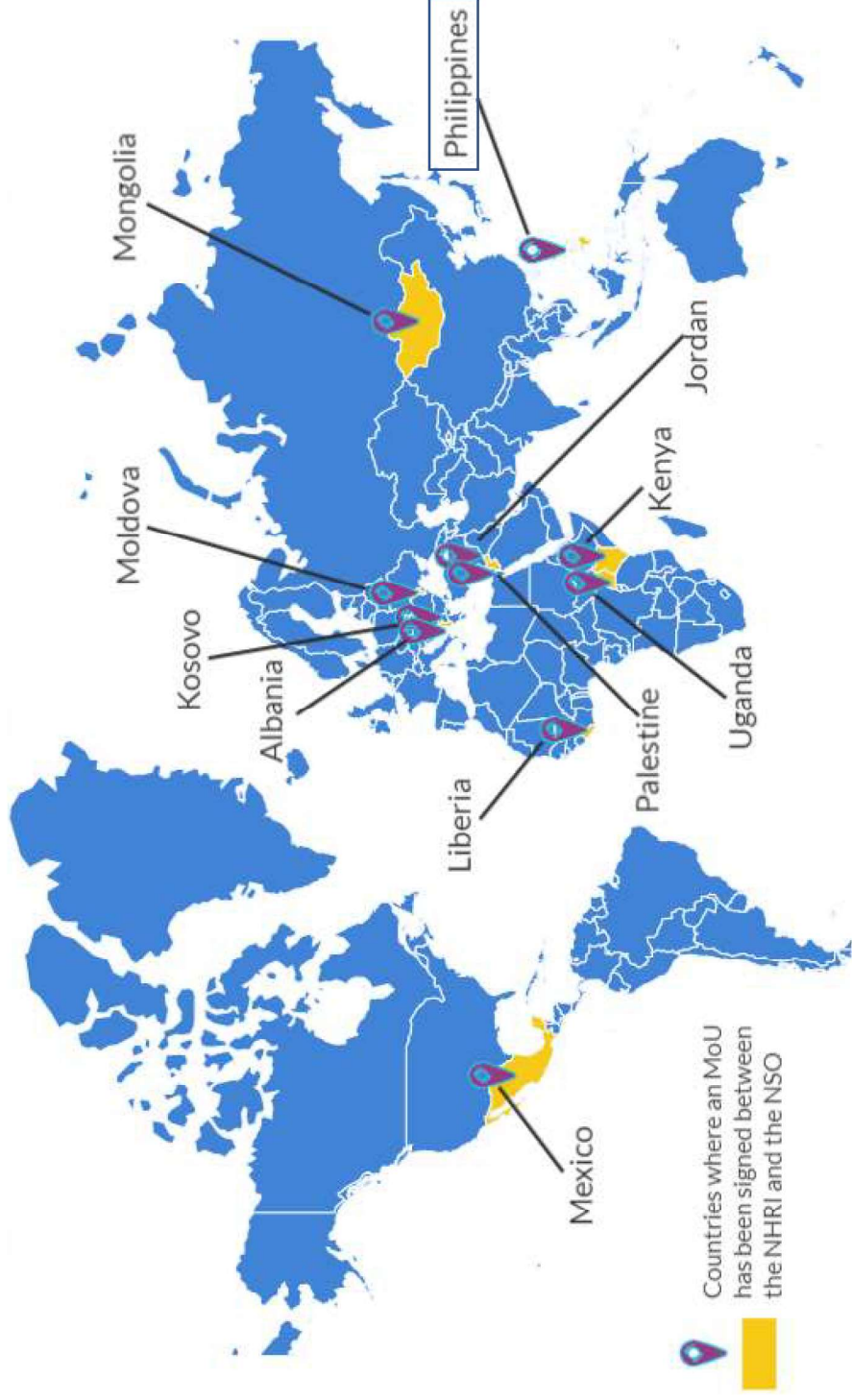

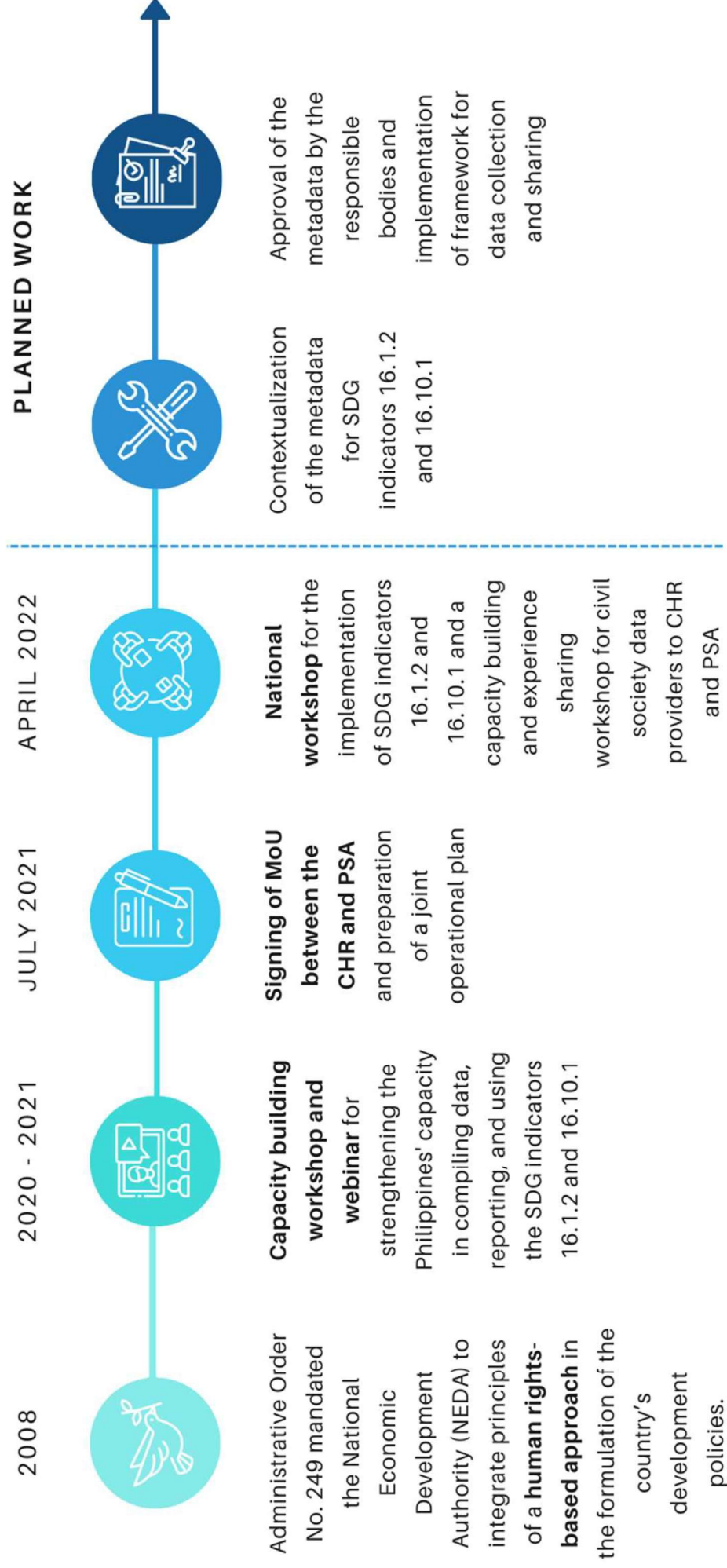
