

**CONTRACT AGREEMENT FOR THE PROCUREMENT OF SUPPLY
AND DELIVERY OF TABLETS FOR THE 2022 CENSUS OF
AGRICULTURE AND FISHERIES (CAF)**

THIS AGREEMENT made the _____ day of APR 24 2022 between **PHILIPPINE STATISTICS AUTHORITY** (hereinafter called "the Entity") of the one part and **MULTIFOCUS CORPORATION**, of Unit 501 One Sulatan Tower #1 Sulatan Street Corner Barangka Drive, Mandaluyong City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the **PROCUREMENT OF SUPPLY AND DELIVERY OF TABLETS FOR THE 2022 CENSUS OF AGRICULTURE AND FISHERIES (CAF)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ONE HUNDRED SEVENTY-FOUR MILLION FOUR HUNDRED FORTY-SEVEN THOUSAND PESOS ONLY (PHP174,447,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **ONE HUNDRED SEVENTY-FOUR MILLION FOUR HUNDRED FORTY-SEVEN THOUSAND PESOS ONLY (PHP174,447,000.00)** or such other sums as may be ascertained, **MULTIFOCUS CORPORATION** agrees to provide **THIRTEEN THOUSAND FIVE HUNDRED UNITS OF TABLETS WITH ACCESSORIES** in accordance with his/her/its Bid.
4. **TERMINATION OF CONTRACT.** **PSA** shall terminate the contract when any of the following conditions attend its implementation:
- 4.1. Outside of force majeure, **MULTIFOCUS CORPORATION** fails to deliver or perform any or all of the Goods within the period(s) specified in the contract, or within any extension thereof granted by **PSA** pursuant to a request made by **MULTIFOCUS CORPORATION** prior to the delay, and such failure amounts to at least ten percent (10%) of the contract price;
 - 4.2. As a result of force majeure, **MULTIFOCUS CORPORATION** is unable to deliver or perform any or all of the Goods, amounting to at least ten percent (10%) of the contract price, for a period of not less than sixty (60) calendar days after the receipt of the notice from **PSA** stating that the circumstance of force majeure is deemed to have ceased; or
 - 4.3. **MULTIFOCUS CORPORATION** fails to perform any other obligation under the Contract.

PSA and **MULTIFOCUS CORPORATION** may also mutually agree on the termination of the agreement.

5. **LIABILITY OF SUPPLIER.** In case the delay in the delivery of Goods exceeds a time duration equivalent to the ten percent (10%) of the specified contract time plus any time extension duly granted to **MULTIFOCUS CORPORATION**, **PSA** may terminate this Contract, forfeit the performance security of **MULTIFOCUS CORPORATION** and award the same to a qualified Supplier.

6. The **PHILIPPINE STATISTICS AUTHORITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.
