#### DECLARING THE BID OFFERED BY DON PIN CORPORATION AS THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT THERETO FOR THE PROCUREMENT OF FIT-OUT FOR THE NETWORK OPERATIONS CENTER AND SECURITY OPERATIONS CENTER (SOC) FOR THE PHILSYS REGISTRY OFFICE (PRO) (REBIDDING)

WHEREAS, on 21 February 2022, the Opening of the Technical Proposal for the Procurement of Fit-Out for the Network Operations Center and Security Operations Center (SOC) for the PhilSys Registry Office (PRO) (Rebidding) was conducted and a lone bidder, Don Pin Corporation (DPC), was declared as eligible after passing the preliminary examination of the bids submitted;

**WHEREAS,** on 28 February 2022, the Bids and Awards Committee (BAC) through Resolution No. 22-02-03 declared the bid of DPC as having passed the Technical Proposal Evaluation for the above-mentioned procurement and with a further instruction to proceed with the Opening of the Financial Proposal;

WHEREAS, on 02 March 2022, the Opening of Financial Proposal from DPC was conducted via the Zoom platform;

WHEREAS, on 10 March 2022, the BAC declared Don Pin Corporation as the Single Calculated Bid (SCB) after the bidder complied to the legal, technical and financial components of the bid at hand;

WHEREAS, on 16 March 2022, post-qualification was conducted at the office of Don Pin Corporation, as well as at the latter's project sites;

**WHEREAS,** on 21 March 2022, the Technical Working Group (TWG) presented the result of the post-qualification report (see attached report);

**WHEREAS**, after verification and validation of the documents presented, the BAC finds the bid evaluation report in order;

#### NOW, THEREFORE, the BAC RESOLVES AS IT IS HEREBY RESOLVED:

- To declare the bid of Don Pin Corporation as the Single Calculated and Responsive Bid (SCRB) for the Procurement of Fit-Out for the Network Operations Center and Security Operations Center (SOC) for the PhilSys Registry Office (PRO) (Rebidding); and
- 2. To recommend the award of contract to the above-mentioned bidder.

#### CONTRACT AGREEMENT FOR THE PROCUREMENT OF FITOUT FOR THE NETWORK OPERATIONS CENTER AND SECURITY OPERATIONS CENTER (SOC) FOR THE PHILSYS REGISTRY OFFICE (PRO) (REBIDDING)

THIS AGREEMENT made this \_\_\_\_\_ day of \_\_\_\_\_ 20\_\_\_ between **PHILIPPINE STATISTICS AUTHORITY** (hereinafter called "the Entity") of the one part and **DON PIN CORPORATION** of DPC Bldg. 320 Romy St., Pasay City, Manila (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the **PROCUREMENT OF FITOUT FOR THE NETWORK OPERATIONS CENTER AND SECURITY OPERATIONS CENTER (SOC) FOR THE PHILSYS REGISTRY OFFICE (PRO) (REBIDDING)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **ELEVEN MILLION FOUR HUNDRED EIGHTY-FOUR THOUSAND THREE HUNDRED THIRTY-EIGHT AND 37/100 PESOS ONLY (PHP11,484,338.37)** (hereinafter called "the Contract Price")

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of ELEVEN MILLION FOUR HUNDRED EIGHTY-FOUR THOUSAND THREE HUNDRED THIRTY-EIGHT AND 37/100 PESOS ONLY (PHP11,484,338.37) or such other sums as may be ascertained, DON PIN CORPORATION agrees to provide FITOUT FOR THE NETWORK OPERATIONS CENTER AND SECURITY OPERATIONS CENTER (SOC) FOR THE PHILSYS REGISTRY OFFICE (PRO) in accordance with its Bid.
- TERMINATION OF CONTRACT. PSA shall terminate the contract when any of the following conditions attend its implementation:
  - 4.1. Outside of force majeure, DON PIN CORPORATION fails to deliver or perform any or all of the Services within the period(s) specified in the contract, or within any extension thereof granted by PSA pursuant to a request made by DON PIN CORPORATION prior to the delay, and such failure amounts to at least ten percent (10%) of the contract price;
  - 4.2. As a result of force majeure, DON PIN CORPORATION is unable to deliver or perform any or all of the Services, amounting to at least ten percent (10%) of the contract price, for a period of not less than sixty (60) calendar days after the receipt of the notice from PSA stating that the circumstance of force majeure is deemed to have ceased; or
  - 4.3. **DON PIN CORPORATION** fails to perform any other obligation under the Contract.

**PSA** and **DON PIN CORPORATION** may also mutually agree on the termination of the agreement.

5. **LIABILITY OF SUPPLIER.** In case the delay in the delivery of Services exceeds a time duration equivalent to the ten percent (10%) of the specified contract time plus any time extension duly granted to **DON PIN CORPORATION**, **PSA** may

terminate this Contract, forfeit the performance security of **DON PIN CORPORATION** and award the same to a qualified Supplier.

6. The **PHILIPPINE STATISTICS AUTHORITY** agrees to pay the abovementioned sum in accordance with the terms of the Bidding.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.
