DECLARING THE BID OFFERED BY ADVANCE SOLUTIONS, INC. AS THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD THERETO FOR THE PROCUREMENT OF 4,000 LICENSES FOR MOBILE DEVICE MANAGEMENT OF THE PHILIPPINE STATISTICS AUTHORITY'S TABLETS DEPLOYED IN PSA OFFICES

WHEREAS, Bids and Awards Committee (BAC) Resolution No. 21-09-04 declared the bid offered by Advance Solutions, Inc. as the Single Calculated Bid (SCB) after the conduct of the detailed bid evaluation on the Procurement of 4,000 Licenses for Mobile Device Management of the Philippine Statistics Authority's Tablets Deployed in PSA Offices;

WHEREAS, pursuant to Section 34.1 of the 2016 Revised Implementing Rules and Regulation (IRR) of Republic Act (RA 9184), the Single Calculated Bid shall "undergo post-qualification in order to determine whether the bidder concerned complies with and is responsive to all the requirements and conditions as specified in the Bidding Documents";

WHEREAS, on 14 September 2021, the post-qualification documents were presented to the BAC;

WHEREAS, the TWG determined that the bid of Advance Solutions, Inc. to be compliant and responsive to the legal, technical and financial requirements of the procurement-at-hand (see attached post-qualification report):

WHEREAS, the BAC, after verification and validation of the documents presented, finds the same to be in order;

NOW, THEREFORE, the BAC RESOLVES AS IT IS HEREBY RESOLVED,

1. To declare the bid offered by Advance Solutions, Inc. as the Single Calculated and Responsive Bid (SCRB) for the Procurement of 4,000 Licenses for Mobile Device Management of the Philippine Statistics Authority's Tablets Deployed in PSA Offices; and
2. To recommend the award of contract to Advance Solutions, Inc. for the above-mentioned procurement

CONTRACT AGREEMENT FOR THE PROCUREMENT OF 4,000 LICENSES
FOR MOBILE DEVICE MANAGEMENT OF THE PHILIPPINE STATISTICS
AUTHORITY'S TABLETS DEPLOYED IN PSA OFFICES

THIS AGREEMENT made this _____ day of _____ 20____ between **PHILIPPINE STATISTICS AUTHORITY** (hereinafter called "the Entity") of the one part and **ADVANCE SOLUTIONS, INC.** of 3rd Floor PPL Building U.N. Avenue, Cor. San Marcelino Street, Paco, Manila, Philippines 1007 (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the **PROCUREMENT OF 4,000 LICENSES FOR MOBILE DEVICE MANAGEMENT OF THE PHILIPPINE STATISTICS AUTHORITY'S TABLETS DEPLOYED IN PSA OFFICES** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **TWO MILLION SIX HUNDRED THOUSAND PESOS ONLY (PHP 2,600,000.00)** (hereinafter called "the Contract Price")

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **TWO MILLION SIX HUNDRED THOUSAND PESOS ONLY (PHP 2,600,000.00)** or such other sums as may be ascertained, **ADVANCE SOLUTIONS, INC.** agrees to provide the **4,000 LICENSES FOR MOBILE DEVICE MANAGEMENT OF THE PHILIPPINE STATISTICS AUTHORITY'S TABLETS DEPLOYED IN PSA OFFICES**, in accordance with its Bid.
4. **TERMINATION OF CONTRACT. PSA** shall terminate the contract when any of the following conditions attend its implementation:
- 4.1. Outside of force majeure, **Advance Solutions, Inc.** fails to deliver or perform any or all of the Goods within the period(s) specified in the contract, or within any extension thereof granted by **PSA** pursuant to a request made by **Advance Solutions, Inc.** prior to the delay, and such failure amounts to at least ten percent (10%) of the contract price;
- 4.2. As a result of force majeure, **Advance Solutions, Inc.** is unable to deliver or perform any or all of the Goods, amounting to at least ten percent (10%) of the contract price, for a period of not less than sixty (60) calendar days after the receipt of the notice from **PSA** stating that the circumstance of force majeure is deemed to have ceased; or
- 4.3. **Advance Solutions, Inc.** fails to perform any other obligation under the Contract.
- PSA** and **Advance Solutions, Inc.** may also mutually agree on the termination of the agreement.
5. **LIABILITY OF SUPPLIER.** In case the delay in the delivery of Goods exceeds a time duration equivalent to the ten percent (10%) of the specified contract time plus any time extension duly granted to **Advance Solutions, Inc.**, **PSA** may terminate this Contract, forfeit the performance security of **Advance Solutions, Inc.** and award the same to a qualified Supplier.
6. The **PHILIPPINE STATISTICS AUTHORITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


