DECLARING THE BID OFFERED BY MC TAGUBA CONSTRUCTION AS THE SINGLE CALCULATED AND RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT THERETO FOR THE PROCUREMENT OF REPAINTING OF INTERIOR & EXTERIOR WALLS FOR TAM AND CVEA BUILDING (REBIDDING)

WHEREAS, on 21 February 2022, the Opening of Bids for the Procurement for Repainting of Interior & Exterior Walls for TAM and CVEA Building (Rebidding) was conducted via Zoom platform;

WHEREAS, only one bidder, MC Taguba Construction, participated in the opening of bids and was declared as eligible for the subject procurement;

WHEREAS, on 28 February 2022, MC Taguba Construction was declared as Single Calculated Bid (SCB) after the bidder was determined to be compliant to the legal, technical and financial requirements of the bid;

WHEREAS, on 09 March 2022, the post-qualification activity was conducted at the Philippine Statistics Authority General Services Division, 11th Floor Centris Cyberpod One, QC;

WHEREAS, on 21 March 2022, the TWG presented the post-qualification result before the BAC (see attached report);

WHEREAS, the BAC, after verification and validation of the documents presented, finds the same to be in order;

NOW, THEREFORE, the BAC RESOLVES AS IT IS HEREBY RESOLVED:

- a. To declare the bid offered by MC Taguba Construction as the Single Calculated and Responsive Bid (SCRB) for the Procurement for Repainting of Interior & Exterior Walls for TAM and CVEA Building (Rebidding); and
- b. To recommend the award of contract to the above-mentioned bidder.

CONTRACT AGREEMENT FOR THE REPAINTING OF INTERIOR & EXTERIOR WALLS FOR TAM AND CVEA BUILDING (REBIDDING)

THIS AGREEMENT made this _____ day of _____ 20____ between **PHILIPPINE STATISTICS AUTHORITY** (hereinafter called "the Entity") of the one part and **MC TAGUBA CONSTRUCTION** of Apostol St., Calamagui 1st, Ilagan City, Isabela (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the **PROCUREMENT FOR REPAINTING OF INTERIOR & EXTERIOR WALLS FOR TAM AND CVEA BUILDING (REBIDDING)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **TWO MILLION FIVE HUNDRED FORTY-ONE THOUSAND FOUR HUNDRED NINE AND 56/100 PESOS ONLY (PHP2,541,409.56)** (hereinafter called "the Contract Price")

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted; *ehy*

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration for the sum of **TWO MILLION FIVE HUNDRED FORTY-ONE THOUSAND FOUR HUNDRED NINE AND 56/100 PESOS ONLY (PHP2,541,409.56)** or such other sums as may be ascertained, **MC TAGUBA CONSTRUCTION** agrees to provide **REPAINTING SERVICES ON THE INTERIOR & EXTERIOR WALLS FOR TAM AND CVEA BUILDING** in accordance with its Bid.
4. **TERMINATION OF CONTRACT. PSA** shall terminate the contract when any of the following conditions attend its implementation:
- 4.1. Outside of force majeure, **MC TAGUBA CONSTRUCTION** fails to deliver or perform any or all of the Services within the period(s) specified in the contract, or within any extension thereof granted by **PSA** pursuant to a request made by **MC TAGUBA CONSTRUCTION** prior to the delay, and such failure amounts to at least ten percent (10%) of the contract price;
- 4.2. As a result of force majeure, **MC TAGUBA CONSTRUCTION** is unable to deliver or perform any or all of the Services, amounting to at least ten percent (10%) of the contract price, for a period of not less than sixty (60) calendar days after the receipt of the notice from **PSA** stating that the circumstance of force majeure is deemed to have ceased; or
- 4.3. **MC TAGUBA CONSTRUCTION** fails to perform any other obligation under the Contract.
- PSA** and **MC TAGUBA CONSTRUCTION** may also mutually agree on the termination of the agreement.
5. **LIABILITY OF SUPPLIER.** In case the delay in the delivery of Services exceeds a time duration equivalent to the ten percent (10%) of the specified contract time plus any time extension duly granted to **MC TAGUBA CONSTRUCTION**, **PSA** may terminate this Contract, forfeit the performance security of **MC TAGUBA CONSTRUCTION** and award the same to a qualified Supplier.
6. The **PHILIPPINE STATISTICS AUTHORITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.




