DECLARING THE BID OF TOYOTA OTIS, INC AS THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING THE AWARD THERETO FOR THE PROCUREMENT OF SUPPLY AND DELIVERY OF THIRTY-SEVEN (37) MULTI-PURPOSE VEHICLE FOR PSA FIELD OFFICES (REBIDDING)

WHEREAS, Bids and Awards Committee (BAC) Resolution No. 21-04-01 dated 05 April 2021 declared the bid offered by Toyota Otis, Inc. as the Lowest Calculated Bid (LCB) for the Procurement of Supply and Delivery of Thirty-Seven (37) Multi-purpose Vehicle for Philippine Statistics Authority (PSA) Field Offices (Rebidding);

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the SUPPLY AND DELIVERY OF THIRTY-SEVEN (37) MULTI-PURPOSE VEHICLE FOR PSA FIELD OFFICES (REBIDDING) and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of FORTY-ONE MILLION SEVEN HUNDRED EIGHTY-SEVEN THOUSAND FIVE HUNDRED SEVENTY-EIGHT PESOS ONLY (PHP 41,787,578.00) (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
- i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that

are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

- 3. In consideration for the sum of FORTY-ONE MILLION SEVEN HUNDRED EIGHTY-SEVEN THOUSAND FIVE HUNDRED SEVENTY-EIGHT PESOS ONLY (PHP 41,787,578.00) or such other sums as may be ascertained, TOYOTA OTIS, INC. agrees to provide the THIRTY-SEVEN (37) MULTI-PURPOSE VEHICLE FOR PSA FIELD OFFICES in accordance with its Bid.
- The PHILIPPINE STATISTICS AUTHORITY agrees to pay the abovementioned sum in accordance with the terms of the Bidding.
