WHEREAS, on 08 November 2022, the opening of bids for the Procurement of Supply and Delivery of Steel Racks was conducted via Zoom platform;

WHEREAS, three (3) bidders participated in the above-mentioned activity, namely:

**WHEREAS**, bidders were declared as eligible after the non-discretionary and preliminary examination of the submitted proposals;

WHEREAS, on 18 November 2022, the Bids and Awards Committee (BAC) through BAC Resolution No. 22-11-08 declared the bid offered by Project Management and Technical Resources Corporation as the Lowest Calculated Bid (LCB) after the conduct of the detailed bid evaluation on the Procurement of Supply and Delivery of Steel Racks;

WHEREAS, on 05 December 2022, the post-qualification activity on Project Management and Technical Resources Corporation was conducted to determine if the bidder complied with and responsive to all the requirements and conditions as specified in the Bidding Documents;

WHEREAS, on 13 December 2022, the post-qualification report was presented to the BAC (see attached post-qualification report);

**WHEREAS**, the Technical Working Group determined the bid of Project Management and Technical Resources Corporation as compliant and responsive to the legal, technical and financial component of the subject procurement;





## CONTRACT AGREEMENT FOR THE PROCUREMENT OF SUPPLY AND DELIVERY OF STEEL RACKS

THIS AGREEMENT made this \_\_\_\_\_ day of \_\_\_\_\_\_ 20\_\_\_\_ between **PHILIPPINE STATISTICS AUTHORITY** (hereinafter called "the Entity") of the one part and **PROJECT MANAGEMENT AND TECHNICAL RESOURCES CORPORATION**, of Up-Town Bldg. 56-58 Madison St. Mandaluyong City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the **PROCUREMENT OF SUPPLY AND DELIVERY OF STEEL RACKS** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **FIVE MILLION FOUR HUNDRED THOUSAND PESOS ONLY (PHP5,400,000.00)** (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, *viz.*:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (*e.g.*, Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and

- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of **FIVE MILLION FOUR HUNDRED THOUSAND PESOS ONLY (PHP5,400,000.00)** or such other sums as may be ascertained, **PROJECT MANAGEMENT AND TECHNICAL RESOURCES CORPORATION** agrees to provide **SUPPLY AND DELIVERY OF STEEL RACKS** in accordance with his/her/its Bid.
- 4. **TERMINATION OF CONTRACT. PSA** shall terminate the contract when any of the following conditions attend its implementation:
  - 4.1. Outside of force majeure, PROJECT MANAGEMENT AND TECHNICAL RESOURCES CORPORATION fails to deliver or perform any or all of the Goods within the period(s) specified in the contract, or within any extension thereof granted by PSA pursuant to a request made by PROJECT MANAGEMENT AND TECHNICAL RESOURCES CORPORATION prior to the delay, and such failure amounts to at least ten percent (10%) of the contract price;
  - 4.2. As a result of force majeure, PROJECT MANAGEMENT AND TECHNICAL RESOURCES CORPORATION is unable to deliver or perform any or all of the Goods, amounting to at least ten percent (10%) of the contract price, for a period of not less than sixty (60) calendar days after the receipt of the notice from PSA stating that the circumstance of force majeure is deemed to have ceased; or
  - 4.3. **PROJECT MANAGEMENT AND TECHNICAL RESOURCES CORPORATION** fails to perform any other obligation under the Contract.

**PSA** and **PROJECT MANAGEMENT AND TECHNICAL RESOURCES CORPORATION** may also mutually agree on the termination of the agreement.

5. **LIABILITY OF SUPPLIER.** When the supplier fails to satisfactorily deliver goods under the contract within the specified delivery schedule, inclusive of duly granted time extensions, if any, the supplier shall be liable for damages for the delay and shall pay the procuring entity liquidated damages, not by way of penalty, an amount equal to one-tenth (1/10) of one percent (1%) of the cost of the delayed goods scheduled for delivery for every day of delay until such goods are finally delivered and accepted by the procuring entity

concerned. The **PSA** need not prove that it has incurred actual damages to be entitled to liquidated damages. Such amount shall be deducted from any money due or which may become due to the supplier, or collected from any securities or warranties posted by the supplier, whichever is convenient to the **PSA**. In case the total sum of liquidated damages reaches ten percent (10%) of the total contract price, the **PSA** may rescind the contract and impose appropriate sanctions over and above the liquidated damages to be paid and award the same to a qualified Supplier.

6.The **PHILIPPINE STATISTICS AUTHORITY** agrees to pay the abovementioned sum in accordance with the terms of the Bidding.

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.


