# DECLARING THE BID OFFERED BY EPLDT, INC. AS THE LOWEST CALCULATED AND RESPONSIVE BID (LCRB) AND RECOMMENDING THE AWARD OF CONTRACT THERETO FOR THE PROCUREMENT OF SUPPLY, DELIVERY, INSTALLATION, CONFIGURATION, SUPPORT AND SUBSCRIPTION OF GOOGLE WORKSPACE FOR ONE (1) YEAR

**WHEREAS**, on 11 July 2022, the Opening of Bids for the Procurement of Supply, Delivery, Installation, Configuration, Support and Subscription of Google Workspace for One (1) Year was conducted via Zoom platform;

WHEREAS, two (2) bidders participated in the above-mentioned activity, namely:

- 1. MaroonStudios, Inc.; and
- 2. ePLDT, Inc.;

**WHEREAS**, both bidders were declared as eligible after the non-discretionary and preliminary examination of the submitted proposals;

**WHEREAS**, Bids and Awards Committee (BAC), through resolution No. 22-07-11 declared the bid of MaroonStudios, Inc. as ineligible and further instructed the Secretariat and the Technical Working Group (TWG) to proceed with the post-qualification with ePLDT, Inc.;

**WHEREAS,** on 05 August 2022, the post-qualification was conducted with ePLDT, Inc.;

**WHEREAS**, on 15 August 2022, the post-qualification report was presented to the BAC (see attached post-qualification report);

**WHEREAS**, based on the report presented, the TWG determined the bid of ePLDT, Inc. as compliant and responsive to the legal, technical and financial component of the subject procurement;

### NOW, THEREFORE, BASED ON THE FOREGOING, the BAC RESOLVES AS IT IS HEREBY RESOLVED,

- 1. To declare the bid proposal of ePLDT, Inc. as the Lowest Calculated and Responsive Bid for the Procurement of Supply, Delivery, Installation, Configuration, Support and Subscription of Google Workspace for One (1) Year, and
  - 2.To recommend the award of contract to the above-mentioned bidder.

## CONTRACT AGREEMENT FOR THE PROCUREMENT OF SUPPLY, DELIVERY, INSTALLATION, CONFIGURATION, SUPPORT AND SUBSCRIPTION OF GOOGLE WORKSPACE FOR ONE (1) YEAR

THIS AGREEMENT made this \_\_\_\_ day of \_\_\_ 20\_\_ between 
PHILIPPINE STATISTICS AUTHORITY (hereinafter called "the Entity") of the one 
part and ePLDT, Inc. of Ramon Cojuangco Bldg., Makati Avenue, Makati City 
(hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the **PROCUREMENT OF SUPPLY**, **DELIVERY**, **INSTALLATION**, **CONFIGURATION**, **SUPPORT AND SUBSCRIPTION OF GOOGLE WORKSPACE FOR ONE (1) YEAR** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **FIFTEEN MILLION EIGHTY-EIGHT THOUSAND EIGHT HUNDRED PESOS ONLY (PHP15,088,800.00)** (hereinafter called "the Contract Price")

#### NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
  - i. Philippine Bidding Documents (PBDs);
    - i. Schedule of Requirements;
    - ii. Technical Specifications;
    - iii. General and Special Conditions of Contract; and
    - iv. Supplemental or Bid Bulletins, if any
  - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;
    - Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
  - iii. Performance Security;

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 3. In consideration for the sum of FIFTEEN MILLION EIGHTY-EIGHT THOUSAND EIGHT HUNDRED PESOS ONLY (PHP15,088,800.00) or such other sums as may be ascertained, ePLDT, Inc. agrees to provide SUPPLY, DELIVERY, INSTALLATION, CONFIGURATION, SUPPORT AND SUBSCRIPTION OF GOOGLE WORKSPACE FOR ONE (1) YEAR in accordance with its Bid.
- 4. TERMINATION OF CONTRACT. PSA shall terminate the contract when any of the following conditions attend its implementation:
  - 4.1. Outside of force majeure, ePLDT, Inc. fails to deliver or perform any or all of the Goods within the period(s) specified in the contract, or within any extension thereof granted by PSA pursuant to a request made by ePLDT, Inc. prior to the delay, and such failure amounts to at least ten percent (10%) of the contract price;
  - 4.2. As a result of force majeure, ePLDT, Inc. is unable to deliver or perform any or all of the Goods, amounting to at least ten percent (10%) of the contract price, for a period of not less than sixty (60) calendar days after the receipt of the notice from PSA stating that the circumstance of force majeure is deemed to have ceased; or
  - 4.3. **ePLDT, Inc.** fails to perform any other obligation under the Contract.

**PSA** and **ePLDT, Inc.** may also mutually agree on the termination of the agreement.

5. **LIABILITY OF SUPPLIER.** In case the delay in the delivery of Goods exceeds a time duration equivalent to the ten percent (10%) of the specified contract time plus any time extension duly granted to **ePLDT, Inc., PSA** may terminate this Contract, forfeit the performance security of **ePLDT, Inc.** and award the same to a qualified Supplier.
