ADOPTED, this 14th day of August 2020 at the Philippine Statistics Authority – Central Office via Zoom Meeting.





**CONTRACT AGREEMENT FOR THE PROCUREMENT OF
PRE-REGISTRATION TABLETS AND WEB-BASED SMS BROADCAST
SERVICES FOR THE PHILSYS PROJECT
(LOT 2)**

KNOW ALL MEN BY THESE PRESENTS:

This CONTRACT is made and entered into this OCT 13 2020 day of _____ at Quezon City, Philippines by and between:

The **PHILIPPINE STATISTICS AUTHORITY**, a national government agency created by virtue of Republic Act No. 10625 with office address at PSA Complex, East Avenue, Diliman, Quezon City, Metro Manila, herein duly represented by its Undersecretary, **CLAIRE DENNIS S. MAPA, Ph.D.**, and hereinafter referred to as the "PROCURING ENTITY";

-and-

The **SMART COMMUNICATIONS, INC.** a corporation duly organized and existing under the laws of the Republic of the Philippines with principal address at Smart Tower, 6799 Ayala Venue, Makati City by **JUAN VICTOR I. HERNANDEZ**, his capacity as Authorized Representative, is hereinafter referred to as the "SUPPLIER";

The PROCURING ENTITY and SUPPLIER are also hereinafter, collectively referred to as "PARTIES" and individually referred to as "PARTY".

WHEREAS, the Procuring Entity invited Bids for suppliers, viz., **PROCUREMENT OF PRE-REGISTRATION TABLETS AND WEB-BASED SMS BROADCAST SERVICES FOR THE PHILSYS PROJECT (LOT 2)** and has accepted a Bid by the Supplier for the said service in the total amount of **TWELVE MILLION PESOS ONLY (PHP 12,000,000.00)** (hereinafter called "the Contract Price");

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
 - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted;
 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract;
 - (f) the Performance Security; and

- (g) the Entity's Notice of Award.
(h) Supplier's terms and conditions

3. In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the latter hereby agrees to deliver the goods and to the former and with all the reasonable speed, repair or replace the defective goods or parts thereof without cost to the Procuring Entity.
4. If the Supplier, having been notified, fails to remedy the defects within the period specified in the contract, the Procuring Entity may then proceed to call upon the warranty security, without prejudice to any other rights which it may have against the Supplier under the contract and under applicable law.
5. The Procuring Entity agrees to observe the Supplier's Terms and Conditions attached herewith as Annex "H" (Terms and Conditions) and endeavors to harmonize such with other contract documents as mentioned above in accordance with the terms of the herein parties.




