**CONTRACT AGREEMENT FOR THE PROCUREMENT OF PRIVATE
AUTOMATIC BRANCH EXCHANGE (PABX) SERVICES FOR
PHILSYS REGISTRY OFFICE (PRO)**

THIS AGREEMENT made this _____ day of JUN 01 2022 20____ between **PHILIPPINE STATISTICS AUTHORITY** (hereinafter called "the Entity") of the one part and **PLDT INC.** of Ramon Cojuangco Bldg., Makati Avenue, Makati City (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly for the **PROCUREMENT OF PRIVATE AUTOMATIC BRANCH EXCHANGE (PABX) SERVICES FOR PHILSYS REGISTRY OFFICE (PRO) (PB 2021-20)** and has accepted a Bid by the Supplier for the supply of those goods and services in the sum of **FOUR MILLION TWO HUNDRED THOUSAND PESOS ONLY (PHP 4,200,000.00)** (hereinafter called "the Contract Price")

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins dated 29 November 2021
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;

- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **FOUR MILLION TWO HUNDRED THOUSAND PESOS ONLY (PHP 4,200,000.00)** or such other sums as may be ascertained, **PLDT, INC.** agrees to provide the **ONE (1) LOT OF PRIVATE AUTOMATIC BRANCH EXCHANGE (PABX) SERVICES FOR PHILSYS REGISTRY OFFICE (PRO)** in accordance with its Bid.

4. **TERMINATION OF CONTRACT.** **PSA** shall terminate the contract when any of the following conditions attend its implementation:

4.1. Outside of force majeure, **PLDT INC.** fails to deliver or perform any or all of the Goods within the period(s) specified in the contract, or within any extension thereof granted by **PSA** pursuant to a request made by **PLDT INC.** prior to the delay, and such failure amounts to at least ten percent (10%) of the contract price;

4.2. As a result of force majeure, **PLDT INC.** is unable to deliver or perform any or all of the Goods, amounting to at least ten percent (10%) of the contract price, for a period of not less than sixty (60) calendar days after the receipt of the notice from **PSA** stating that the circumstance of force majeure is deemed to have ceased; or

4.3. **PLDT INC.** fails to perform any other obligation under the Contract.

PSA and **PLDT INC.** may also mutually agree on the termination of the agreement.

Any amount paid prior to the termination of the Contract shall be deemed to be service and/or lease payments for the use of the PABX System. The Supplier reserves the right to recover the PABX System if **PSA** has not yet fully paid the Contract Price at the time of termination of the Contract.

5. **LIABILITY OF SUPPLIER.** In case the delay in the delivery of Goods exceeds a time duration equivalent to the ten percent (10%) of the specified contract time plus any time extension duly granted to **PLDT INC., PSA** may terminate this

Contract, forfeit the performance security of **PLDT INC.** and award the same to a qualified Supplier.

6. The **PHILIPPINE STATISTICS AUTHORITY** agrees to pay the above-mentioned sum in accordance with the terms of the Bidding.

The Contract Price shall be paid in 36 equal monthly installments from the acceptance of the Service. Upon payment of the full Contract Price, title to the PABX equipment (as provided in the Bid Documents) shall transfer to PSA. Upon full payment of the Contract Price, the Supplier shall execute the necessary documents showing the transfer of ownership of the PABX equipment.

7. This Agreement shall be effective from the date indicated above and shall be valid for a term of three years from acceptance of the service. For the avoidance of doubt, the Telecom Services, specifically local voice calls, NDD and on-net (Smart/Sun) voice calls, shall have a fixed term of one year from acceptance of the service. Thereafter, PSA may renew the Telecom Service in accordance with the Guidelines On Procurement Of Water, Electricity, Telecommunications And Internet Service Providers (Appendix 21, 2016 IRR of RA 9184).

IN WITNESS whereof the parties hereto have caused this Agreement to be executed in accordance with the laws of the Republic of the Philippines on the day and year first above written.

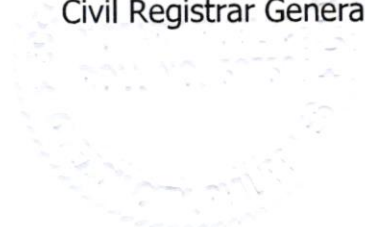


