**CONTRACT FOR CONSULTANCY SERVICES AS SYSTEMS INTEGRATOR
FOR THE SUPPLY, DELIVERY, INSTALLATION, AND MAINTENANCE
OF THE PHILIPPINE IDENTIFICATION SYSTEM (PHILSYS)**

THIS CONTRACT, made this **SEP 11 2020** day of September, 2020 by and between:

- (A) PHILIPPINE STATISTICS AUTHORITY, a national government agency created by virtue of Republic Act No. 10625, with principal office at PSA Complex East Avenue, Diliman Quezon City, and represented herein by its National Statistician and Civil Registrar-General, UNDERSECRETARY CLAIRE DENNIS MAPA, Ph.D., (hereinafter called the "Procuring Entity") and
- (B) MADRAS SECURITY PRINTERS PRIVATE LIMITED, a corporation incorporated under the laws of India, with principle office at 72 Thiruvottiyur High Road, Chennai - 600 081, Chennai Tamil Nadu, India,

in JOINT VENTURE with

MEGA DATA CORPORATION, a corporation incorporated under the laws of the Philippines, with principal office at MEGA-RMG3 Bldg., 667 Sgt. Bumatay Street, Plainview, Mandaluyong City, Metro Manila.

(hereinafter, singly and jointly referred to as the "Consultant")

WHEREAS, the Procuring Entity desires to engage the Consultant as Systems Integrator for the supply, delivery, installation, and maintenance of the Philippine Identification System (PhilSys) (hereinafter called "the Consulting Services") and the Procuring Entity has accepted the bid for **Two Billion One Hundred Ninety Eight Million Seven Hundred Eleven Thousand Four Hundred Eighteen and 40/100 Pesos (PhP 2,198,711,418.40)**, inclusive of all taxes, by the Consultant for the execution and completion of such Consulting Services and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Contract, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents (each a "Contract Document") shall be attached, deemed to form, and be read and construed as part of this Contract, to wit:
 - (a) General and Special Conditions of Contract;
 - (b) Technical Specifications;
 - (c) Request for Expression of Interest;
 - (d) Instructions to Bidders (ITB);
 - (e) Bid Data Sheet;
 - (f) Addenda and/or Supplemental/Bid Bulletins, if any


- (g) Bid forms, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents/statements submitted (e.g., bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
- (h) Eligibility requirements, documents and/or statements;
- (i) Performance Security; and
- (j) Notice of Award of Contract and the Bidder's conforme thereto.

In the event of any ambiguity or conflict between the foregoing Contract Documents, the order of precedence shall be the order in which the Contract Documents are listed above.


3. In consideration of the payments to be made by the Procuring Entity to the Consultant, the Consultant hereby covenants with the Procuring Entity to execute and complete the Consulting Services and remedy any defects therein in conformity with the provisions of this Contract.
4. The Procuring Entity hereby covenants to pay the Consultant in consideration of the execution and completion of the Consulting Services, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.

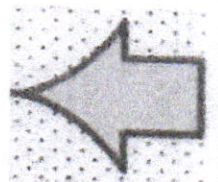
