## CONTRACT AGREEMENT FOR THE PROCUREMENT OF SUPPLY AND DELIVERY OF 1000 UNITS OF DESKTOP COMPUTERS

KNOW ALL MEN BY THESE PRESENTS:

This CONTRACT is made and entered into this 15/h day of 1000 Juptum but 2020 at Quezon City, Philippines by and between:

The **PHILIPPINE STATISTICS AUTHORITY**, a national government agency created by virtue of Republic Act No. 10625 with office address at PSA Complex, East Avenue, Diliman, Quezon City, Metro Manila, herein duly represented by its Undersecretary, **CLAIRE DENNIS S. MAPA**, **Ph.D.**, and hereinafter referred to as the "PROCURING ENTITY";

#### -and-

The **MASANGKAY COMPUTER CENTER** a corporation duly organized and existing under the laws of the Republic of the Philippines with principal address at 1143 G. Masangkay Street Sta. Cruz, Manila by **PETER KO**, his capacity as Owner and Sole Proprietor, is hereinafter referred to as the "SUPPLIER";

The PROCURING ENTITY and SUPPLIER are also hereinafter, collectively referred to as "PARTIES" and individually referred to as "PARTY".

WHEREAS, the Procuring Entity invited Bids for suppliers, viz., **PROCUREMENT OF SUPPLY AND DELIVERY OF 1000 UNITS OF DESKTOP COMPUTERS** and has accepted a Bid by the Supplier for the said service in the total amount of **THIRTY TWO MILLION THREE HUNDRED THOUSAND PESOS (PHP 32,300,000.00)** (hereinafter called "the Contract Price"):

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
- 2. The following documents shall be deemed to form and be read and construed as part of this Agreement, viz.:
  - (a) the Supplier's Bid, including the Technical and Financial Proposals, and all other documents/statements submitted;
  - (b) the Schedule of Requirements;
  - (c) the Technical Specifications;
  - (d) the General Conditions of Contract;
  - (e) the Special Conditions of Contract;
  - (f) the Performance Security; and
  - (g) the Entity's Notice of Award.



- 3. In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to deliver the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- The Entity hereby covenants to pay the Supplier in consideration of the delivery of the goods and the remedying of the defects therein, the Contract Prices or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the Contract.
