This CONTRACT is made and entered into this DEC 18 2019 day of _____ at Quezon City, Philippines by and between:

The **PHILIPPINE STATISTICS AUTHORITY**, a national government agency created by virtue of Republic Act No. 10625 with office address at PSA Complex, East Avenue, Diliman, Quezon City, Metro Manila, herein duly represented by its Undersecretary, **CLAIRE DENNIS S. MAPA, Ph.D.**, and hereinafter referred to as the "PROCURING ENTITY";

The **ePLDT INC.** a corporation duly organized and existing under the laws of the Republic of the Philippines with principal address at 5th Floor, L.V. Locsin Bldg., Makati Avenue, Makati City by **JUAN VICTOR I. HERNANDEZ**, his capacity as President, and Chief Executive Officer, is hereinafter referred to as the "SUPPLIER";

The PROCURING ENTITY and SUPPLIER are also hereinafter, collectively referred to as "PARTIES" and individually referred to as "PARTY".

 - (e) the Special Conditions of Contract;
 - (f) the Performance Security; and
 - (g) the Entity's Notice of Award.

3. In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to deliver the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the delivery of the goods and the remedying of the defects therein, the Contract Prices or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the Contract.


