WHEREAS, the Philippine Statistics Authority (PSA), through its Bids and Awards Committee (BAC), received a Purchase Request (PR) with No. PSYS-19-08-056 for the Procurement of Full Managed Contact Center for the Implementation of Philippine Identification System (PSYS) with an Approved Budget of the Contract amounting to Five Million Four Hundred Thousand Pesos (Php 5,400,000.00);

WHEREAS, BAC Resolution No. 19-09-07 dated 13 September 2019 stated the approval of the bidding document and the posting of the same during the Pre-Procurement Conference at the 17th Flr., Conference Room, Centris Cyberpod Three, Quezon City;

WHEREAS, BAC Resolution No. 19-09-11 dated 07 October 2019 declared PILIPINAS TELESERV INC. as the Lowest Calculated Bid (LCB) and subsequently, was recommended to conduct a post-qualification for verification;

WHEREAS, on 21 October 2019, the Technical Working Group for the above-mentioned procurement submitted the result of the Post-qualification conducted on 18 October 2019;

WHEREAS, based on the post-qualification report dated 21 October 2019, the PILIPINAS TELESERV INC. has passed the verification process and was determined responsive to the requirements and conditions specified in the bidding document

NOW, THEREFORE, the BAC RESOLVES AS IT IS HEREBY RESOLVED,

To:
