**RECOMMENDING THE AWARD OF CONTRACT TO NEC PHILIPPINES FOR THE
PROCUREMENT OF UNIFIED MULTI-PURPOSE IDENTIFICATION - CENTRAL
VERIFICATION SYSTEM (UMID-CVS) OPERATION AND MAINTENANCE WITH
IMMEDIATE REPLACEMENT, REPAIR AND INSTALLATION OF DEFECTIVE
HARDWARE COMPONENTS UNDER DIRECT CONTRACTING MODE OF
PROCUREMENT**

WHEREAS, the Bids and Award Committee (BAC) through its Secretariat received the Purchase Request for the procurement of Unified Multi-Purpose Identification Central Verification System (UMID-CVS) Operation and Maintenance with immediate replacement, repair and installation of defective hardware components with an Approved Budget of the Contract amounts to Fifteen Million and Four Hundred Fifty Thousand Pesos Only (Php 15,450,000.00);

WHEREAS, BAC Resolution No. 20-06-10 indicated the approval of the Head of Procuring Entity (HoPE) to subject the above-mentioned procurement under Direct Contracting Mode of Procurement with the NEC Philippines;

WHEREAS, a Request for Quotation (RFQ) was prepared and consequently sent to NEC Philippines on 02 July 2020;

WHEREAS, the Secretariat received the proposal/bid of NEC Philippines on 07 July 2020 at 9:40AM which is before the prescribed deadline of submission of bids;

WHEREAS, NEC Philippines offered a bid in the amount of Fifteen Million Four Hundred Forty-One Thousand Five Hundred Twenty-Nine and 65/100 Pesos (Php 15,441,529.65), which is within the Approved Budget of the Contract for the above-mentioned procurement;

WHEREAS, the BAC finds the bid of NEC Philippines compliant, and the supplier legally and technically capable to deliver the goods at the most advantageous price and contract for the Government;

NOW, THEREFORE, the BAC RESOLVES AS IT IS HEREBY RESOLVED, to recommend to the HoPE the award of contract to NEC Philippines in the amount of Fifteen Million Four Hundred Forty-One Thousand Five Hundred Twenty-Nine and 65/100 Pesos (Php 15,441,529.65) for the procurement of Unified Multi-Purpose Identification Central Verification System (UMID-CVS) Operation and Maintenance with immediate replacement, repair and installation of defective hardware components.



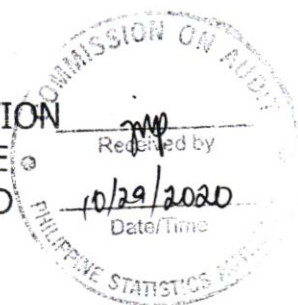

This CONTRACT is made and entered into this SEP 14 2020 day of _____ at Quezon City, Philippines by and between:

The **PHILIPPINE STATISTICS AUTHORITY**, a national government agency created by virtue of Republic Act No. 10625 with office address at PSA Complex, East Avenue, Diliman, Quezon City, Metro Manila, herein duly represented by its Undersecretary, **CLAIRE DENNIS S. MAPA, Ph.D.**, and hereinafter referred to as the "PROCURING ENTITY";

The **NEC PHILIPPINES, INC.**, a corporation duly organized and existing under the laws of the Republic of the Philippines, with principal address at 7th Floor, 111 Paseo De Roxas Bldg., Paseo De Roxas Legaspi Village, San Lorenzo, Makati City, herein duly represented by its President, **JOJI YAMAMOTO**, and hereinafter referred to as the "SUPPLIER";

The PROCURING ENTITY and SUPPLIER are also hereinafter, collectively referred to as "PARTIES" and individually referred to as "PARTY".

WHEREAS, the Procuring Entity invited Bids for suppliers, viz., **UNIFIED MULTI-PURPOSE IDENTIFICATION CENTRAL VERIFICATION SYSTEM (UMID-CVS) OPERATIONS SUPPORT AND HARDWARE MAINTENANCE WITH IMMEDIATE REPLACEMENT, REPAIR AND INSTALLATION OF DEFECTIVE HARDWARE COMPONENTS** and has accepted a Bid by the Supplier for the said service in the total amount of **FIFTEEN MILLION FOUR HUNDRED FORTY-ONE THOUSAND FIVE HUNDRED TWENTY-NINE AND 65/100 PESOS ONLY (PHP 15,441,529.65)** (hereinafter called "the Contract Price");
