DECLARING TRENDS AND TECHNOLOGIES, INC. AS THE SINGLE CALCULATED & RESPONSIVE BID (SCRB) AND RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT FOR THE SUPPLY AND DELIVERY OF VIRTUALIZATION LICENSE (REPOSTING) TO THE SAID BIDDER BY THE BIDS AND AWARDS COMMITTEE (BAC) MEMBERS

WHEREAS, the Philippine Statistics Authority (PSA) advertised the Invitation to Bid on 28 December 2018 in the Philippine Government Electronic Procurement System, PSA Website and conspicuous places at the PSA Central Offices for seven (7) calendar days;

WHEREAS, on 04 January 2019, a Pre-Bid Conference was held at FAS Training Room, 11th Floor Cyberpod Centris One and only Trends and Technologies, Inc. attended in response to the advertisement;

WHEREAS, only Trends and Technologies, Inc. purchased the bidding documents and submitted a bid before the deadline of the Submission and Opening of Bids on 17 January 2019;

WHEREAS, during the opening of bids, the bid proposals of Trends and Technologies, Inc. were found to be substantially complying;

WHEREAS, the bid submitted by Trends and Technologies, Inc. in the amount of **NINE HUNDRED TWENTY THOUSAND ONE HUNDRED EIGHTY PESOS (PHP920,188.00) ONLY** is lower than the Approved Budget for the Contract (ABC) of One Million Two Hundred Thousand Pesos (PHP1,200,000.00);

WHEREAS, the BAC Resolution No. 19-01-12 declared the bid submitted by Trends and Technologies, Inc. as the Single Calculated Bid (SCB);

WHEREAS, the Post Qualification Team (PQT) conducted a post qualification process on the said bidder on 18 February 2019 and found the legal, technical and financial documents to be in order;

WHEREAS, the Technical Working Group Evaluation Report No. 19-02-78 dated 18 February 2019 recommended the award of contract of the said procurement to Trends and Technologies, Inc.;

WHEREAS, in view of the foregoing, the BAC hereby recommends that the bid submitted by Trends and Technologies, Inc. as the Single Calculated and Responsive Bid (SCRB);



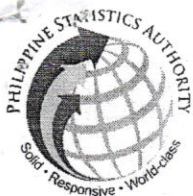

**CONTRACT AGREEMENT FOR THE PROCUREMENT FOR THE SUPPLY
AND DELIVERY OF VIRTUALIZATION LICENSE**

KNOW ALL MEN BY THESE PRESENTS:

This Agreement entered into this MAY 12 2010 day of _____ at Quezon City by and between:

The **PHILIPPINE STATISTICS AUTHORITY (PSA)**, duly organized and existing under and by virtue of the laws of the Republic of the Philippines, with principal address at PSA Complex, East Avenue, Diliman, Quezon City and represented by its Assistant Secretary and Officer-in-Charge, JOSIE B. PEREZ, hereinafter referred to as the "PROCURING ENTITY";

-and-

The **TRENDS AND TECHNOLOGIES, INC.**, a company duly organized and existing under the laws of the Republic of the Philippines with principal address at 6/F Trafalgar Plaza, 105 H. V. Dela Costa Street, Salcedo Village, Makati City by Ms. Patricia Nicole C. Domingo, her capacity as Authorized Representative, and authorized representative/signatory, is hereinafter referred to as the "SUPPLIER";

WHEREAS, the Procuring Entity invited Bids for suppliers, viz., **Procurement for the Supply and Delivery of Virtualization License** and has accepted a Bid by the Supplier for the said goods in the total amount of **NINE HUNDRED TWENTY THOUSAND ONE HUNDRED EIGHTY EIGHT PESOS (PHP920,188.00)** (hereinafter called "the Contract Price");

 - (b) the Schedule of Requirements;
 - (c) the Technical Specifications;
 - (d) the General Conditions of Contract;
 - (e) the Special Conditions of Contract;

(f) the Performance Security; and

(g) the Entity's Notification of Award.

3. In consideration of the payments to be made by the Procuring Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to deliver the goods and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of the defects therein, the Contract Price or such other sum as may become payable under the provisions of the contract at the time and in the manner prescribed by the Contract.
