CBMS Council Resolution No. 03, Series of 2021

APPROVING THE ESTABLISHMENT OF THE TECHNICAL WORKING GROUPS (TWGs) AND THEIR TERMS OF REFERENCES

WHEREAS, Republic Act No. 11315 otherwise known as Community-Based Monitoring System Act (CBMS Act) was enacted on 17 April 2019, institutionalizing the conduct of the Community-Based Monitoring System (CBMS) in every city and municipality in the country;

WHEREAS, Section 14 of the Act provides for the creation of the CBMS Council composed of the Philippine Statistics Authority (PSA), Department of the Interior and Local Government (DILG) and Department of Information and Communications Technology (DICT), to be headed by the PSA, for purposes of achieving secure and efficient data sharing arrangements between and among concerned cities and municipalities and national government agencies to be used for their particular social protection and welfare programs and projects;

WHEREAS, one of the functions of the CBMS Council as enumerated in Section 2 (i) Rule XI of the Implementing Rules and Regulations (IRR) of the CBMS Act is to establish Technical Working Groups (TWGs) that will assist in resolving issues related to the implementation of the CBMS;

WHEREAS, the CBMS Council deemed it proper to establish the following TWGs. to wit:

- TWG on Data Sharing and Privacy
- TWG on Technology for CBMS Operations
- TWG on Training and Capacity Development
- TWG on Information and Education Campaign
- TWG on Local Government Coordination
- TWG on Financial and Resource Sharing

WHEREAS, the TWGs will be providing technical assistance to the CBMS Council in settling issues related to the implementation of the CBMS. Each TWG will serve as supporting and coordinating body that aims to provide valuable input based on their scope of work.

NOW, THEREFORE BE IT RESOLVED, that the CBMS Council established the aforementioned TWGs pursuant to Section 2 (i) Rule XI of the IRR of the CBMS Act.



RESOLVED FURTHER, that the CBMS Council approves and adopts the Terms of References for all the TWGs in relevance to the implementation of the CBMS Act as hereto attached (CBMS CR 03-20210127-01);

RESOLVED FINALLY, that a CBMS Council member may move to create other TWGs composed of government agencies and concerned instrumentalities from the pool of resource agencies as the need arises, subject to the concurrence of other members.
