Safety and Health Practices in the Real Estate, Renting and Business Activities Industry: 2008

(Twelfth of a series on Industrial Relations Practices)

The Bureau of Labor and Employment Statistics (BLES) in coordination with the DOLE Regional Offices conducted the 2007/2008 BLES Integrated Survey (BITS) covering 6,460 non-agricultural sample establishments employing 20 or more workers nationwide. The main objective of the survey is to generate integrated data sets on employment of specific groups of workers, occupational shortages and surpluses, safety and health practices, occupational injuries and diseases and labor cost of employees.

This issue presents the survey highlights of the safety and health practices adopted and implemented by establishments in the real estate, renting and business activities as of June 30, 2008. It provides information on the safety and health of persons at work, as well as on the protection of other individuals against risk to their safety and health in connection with or as affected by activities of persons at work.

OVERVIEW

The real estate, renting and business activities industry is mainly composed of establishments engaged in real estate activities with own or leased properties; renting of machinery and equipment without operator; personal and household goods; computer and related activities; research and development; and miscellaneous business activities.

In June 2008, the industry reported a total employment of 614,529 or 20.5% of the total paid employees in non-agricultural establishments with 20 or more workers.

Expansion in the industry's employment has been due primarily to the expansion of job opportunities specifically in business process outsourcing (BPO) activities, e.g. call centers and medical transcriptions.

As call center agents and medical transcriptionists comprised 4 out of every 10 employed persons in establishments engaged in business activities, increasing concerns were raised on the occupational safety and health of these workers who are mostly working on graveyard shifts.

SURVEY HIGHLIGHTS

The following are the highlights of the occupational safety and health practices implemented in establishments engaged in real estate, renting and business activities:

... as to available facilities provided

Most establishments in the industry provided adequate supply of safe drinking water (95.8%); adequate space that allow sufficient freedom of movement to perform duties (95.5%); proper ventilation in work areas (94.1%); water tank and functioning fire extinguishers within reach (93.2%); and clean and hygienic comfort rooms (93.0%).

Similarly, a large number of establishments also had well-maintained office building (92.8%); adequate aisles/ passageways (92.5%); adequate lighting including emergency lights (91.8%); and adequate exhaust system (81.1%).

Only few establishments had sports/recreational facilities (24.1%); pipe-in music (24.0%); and facilities for

persons with disabilities (20.2%). (Table 1)

Of the total establishments that did not provide some of the health and safety facilities, 3 out of every 5 (58.4%) considered some of these facilities as not necessary while around half (51.4%) believed that these facilities were not applicable/suitable their to reasons establishments. Other cited include: no available space (32.2%); very few workers (23.3%); too costly (20.0%); and not required by law (1.5%).

...as to programs/services implemented

Four out of every 5 establishments in real estate, renting and business activities industry conducted regular inspection and maintenance of equipment (81.3%) and had available first-aid kits (80.8%). Other health and safetv programs implemented were as follows: free health and/or accident insurance drug-free (70.5%);workplace policy/program (67.0%);emergency response preparedness program (62.4%); random drug testing (60.7%); accident prevention program (59.5%); regular monitoring of hazards (56.5%); and free health plan by a health maintenance organization (50.7%). ... as to preventive and control measures adopted

More than four-fifths of the establishments implemented the following preventive and control measures: of portable/built-in provision fire extinguishers (83.5%); conduct of regular maintenance of mechanical and electrical facilities (76.0%); and proper operational procedures in doing the job (75.8%).

Other control measures adopted include: security measures to reduce exposure to physical danger or (61.5%); emergency/evacuation plan (59.7%);proper postina of safetv sianaaes (58.9%); instruction training on health (57.8%); safety conduct and of emergency drills (55.2%); advisory services on occupational safety/health (54.2%); regular pest control treatment (54.0%); and available safety manuals, labels maintenance procedures or (53.4%). (Table 3)

... as to trainings and seminars conducted

Health and safety trainings/ seminars commonly conducted among establishments in real estate, renting and business activities industry were safety drills (65.9%); first aid (62.4%); safe work procedures (57.4%); and accident investigation (50.2%).

One out of every 10 establishments provided training on family planning and reproductive health. (*Table 4*)

...as to agencies involved in trainings/seminars conducted

Some establishments tapped the assistance of the following agencies in the conduct of their occupational health and safety trainings: Occupational Safety and Health Center (24.1%); DOLE Regional Offices (23.7%); DOLE Accredited Safety Training and Consultancy Organizations (22.3%); and NGOs/Universities/ Academic Institutions (21.6%).

... as to person responsible in the implementation/monitoring of safety and health practices

Implementation of safety and health practices in establishments engaged in real estate, renting and business activities were primarily implemented by managing proprietors/owner (49.2%); human resource manager (47.9%); general manager (41.3%); and production/ operations manager (37.2%).

... as to personnel who administered medical services

Seven out of everv 10 establishments (73.7%) relied on the medical services of nearest clinics/hospitals for their health and rest medical needs. The of the establishments had trained first-aiders (32.6%); registered nurses (17.4%); physicians (14.6%); and dentists (4.4%).

... as to occupational safety and health records

To monitor occupational safety and health of workers, 2 out of every 5 establishments (40.6%) in real estate, renting and business activities industry kept records of Work Accident/Illness Report. About one-third (33.0%) got records of Annual Medical Report while only few (10.7%) had Minutes of Meeting of Health and Safety Committee.

... as to communication method used

Majority of the establishments used the general assemblies/meetings (68.7%) to communicate information on safety and health to their employees. Such information was also communicated through the conduct of drills (29.2%); newsletters/staff bulletins (27.7%); and posters in conspicuous places (22.9%).

Only a small proportion of establishments made use of the Labor Management Cooperation/Council meetings (2.7%).

... as to frequency of management consultation

Almost half of the establishments "sometimes" (47.9%) consulted employee representatives or union officers on matters concerning occupational safety and health matters while 4 out of every 10 establishments conducted consultation "always" (41.2%).

... as to ISO certifications held

Of the total establishments in the industry, only 1 out of every 10 had certification on ISO 9001:2000-Quality Management System. Others got certifications ISO 27001/27002on Information Security Management 18001-Occupational (2.6%);OHSAS Health and Safety Management Standard (0.7%);ISO 14001-Environmental Management Standard (0.4%); SA 8000-Social Accountability Standard (0.2%); and ISO 12006-Building Construction (0.1%).
