## PROFILE OF PERSONS EMPLOYED IN PRIVATE HOUSEHOLDS


On 16 June 2011, the International Labour Conference of the International Labour Organization (ILO) adopted the Convention concerning decent work for domestic workers, which is also referred to as the Domestic Workers Convention, 2011 (No. 189). This convention lays down the basic rights and principles, and requires States to take a series of measures with a view to making decent work a reality for domestic workers.

Under the convention, a domestic worker is "any person engaged in domestic work within an employment relationship". A domestic worker may work on full-time or part-time basis; may be employed by a single household or by multiple employers; may be residing in the household of the employer (live-in worker) or may be living in his or her own residence (live-out). A domestic worker may be working in a country of which she/he is not a national.

The Labor Force Survey (LFS) conducted quarterly by the National Statistics Office provides the magnitude of this household workforce in the country. This can be captured in terms of economic activity or industry, e.g., "persons employed in private households" or through the relationship of a resident individual to the household head, as in the case of live-in domestic helpers. On the other hand, persons employed in private households may or may not be members of the households.


This issue of LABSTAT Updates describes the profile of persons employed in private households and live-in domestic helpers which were culled from the 2010 LFS.


- 1.9 million workers aged 15 years and over were employed in private households.
- Live-in domestic helpers accounted for 30.4% or 585,000 of this number.
- Women outnumbered men in the overall proportion of employed in private households (84.5% vs. 15.5%); a higher proportion was noted among those who are live-in workers (92.1% vs. 7.9%).
- On the average, men household workers were a year older than the women workers (35 vs. 34).
- Women live-in workers were a year older than men (29 vs. 28). (Table 1)
- About one-third (32.1%) of persons employed in private households belong to the 15-24 age bracket.
- The proportion of young live-in domestic helpers reached 51.8%. (Figure 1)





- Workers 15 to 17 years old numbered 178,000 or 9.2% of employed in private households.
- Of this, 87,000 were live-in domestic workers.
   Large majority of these working children were women (93.1%). (Table 1)

- Single (45.8%) and married (43.5%) were almost equally represented among workers employed in private households.
- Live-in domestic helpers were predominantly single (76.6%). (Figure 2)
- More than half (55.9%) of workers employed in private households had reached/completed secondary education.
- The proportion among the live-in domestic helpers with secondary education was higher at 66.0%. (Figure 3)
- Large majority of household workers (84.0%) were in services elementary occupations working as launderers, gardeners, and domestic helpers; more women (89.7%) than men (52.5%) work in these occupations relative to their respective populations.
- Almost all (97.6%) live-in domestic workers worked as launderers, gardeners, and domestic helpers. (Figure 4)
- Workers in private households rendered an average of 52 hours per week (normal hours per day at 8.9).
- Women household workers spent slightly longer hours of work per week than their men counterparts (52.1 vs. 51.4).
- Live-in domestic workers worked longer hours per week than private household workers at 66 (normal hours per day at 10.3).
- Women live-in workers worked 5.2 hours longer per week than their men counterparts (66.4 vs. 61.2). (Figure 5)









- One-fifth (19.5% or 376,000) of persons employed in private households were found in NCR.
- Lesser proportions were noted in Region IV-A (13.7% or 263,000), Region VI (10.0% or 192,000), Region VII (9.9% or 190,000), and Region III (9.8% or 188,000).
- Regional distribution of live-in domestic workers was similar with that of persons employed in private households. (Table 1)
- Workers employed in private households received an average daily basic pay of £133.20 with men earning more (£188.17) than women (£123.20).

- Household workers in NCR received the highest average basic pay of P181.09; workers in Region XII received the least at P85.11.
- Live-in domestic workers received an average daily basic pay of #100.85 or #32.35 lower than those received by persons employed in private households.
- Live-in domestic helpers in NCR received the highest daily basic pay of #130.60; workers in ARMM the lowest at #49.59. (Figure 6)
- In contrast, women live-in domestic helpers received higher pay at ₱101.08 compared to ₱98.14 of men


