INVESTMENT IN HUMAN RESOURCES

A survey of job-related trainings in establishments with 20 or more workers



This LABSTAT Updates presents the highlights of the module on Training of Workers of the 2013/2014 Integrated Survey on Labor and Employment (ISLE). The ISLE is a nationwide sample survey covering 8,399 establishments with 20 or more workers. This issue focuses on establishment practices as these relate to training of workers and how these vary across industries. The reference period for this module covered the calendar year 2013.

Training is a key management tool in managing the human resource development (HRD) program of an organization. The success of any business lies on the knowledge and skills of its workforce which must be constantly enhanced and enlarged through training to keep pace with the increasingly competitive business environment. Training of workers is a form of investment that contributes to the sustainability and profitability of a business.

This issue presents statistics on the number of workers trained in establishments with 20 or more workers; the category of workers given job-related trainings; and type of training providers.

One in every two establishments provided job-related trainings to their workers

 Out of the estimated 34,579 establishments with 20 or more workers, 45.6% or 15,759 provided job-related trainings to their workers in 2013. (Table 1)

The proportions of establishments providing job-related varied across industries. highest was noted in water supply, sewerage, waste management and remediation activities (66.6%)followed by private education (59.4%), financial and insurance activities (58.9%), and construction (58.4%). The lowest professional, scientific and technical activities (32.8%). (Table 2)


Nearly one-third of the total provided workforce were iobrelated proportion trainings; highest among workers electricity, air gas, steam and conditioning supply

- More than one million (1,378,849) workers were provided job-related trainings in 2013. This corresponds to approximately one-third (30.8%) of 4,471,785 total employed. (Table 3)
- In relation to respective industry employment, electricity, gas, steam air conditioning registered the highest proportion of workers trained (68.5%). This was followed by water sewerage, waste management and remediation activities (52.5%);information and communication (42.8%); financial and insurance activities (40.7%); and private health and social work activities (39.7%). (Figure 1)
- In sub-sectors with large number of workers, the proportion of employees trained was close to the

- overall industry average of 30.8 percent such as administrative and support service activities (32.2%), where business process outsourcing (BPO) belongs; and manufacturing (30.3%).
- The lowest proportion of workers registered trained was in 7.9%. construction at Lower proportions were also reported in arts, entertainment and recreation (17.7%); mining and guarrying (17.8%); and repair of computers and personal and household goods and other personal service activities (20.6%).

Majority of workers trained were rank and file

- In 2013, rank and file workers represented the bulk (77.7% or 1,071,309) of total workers granted job-related trainings by the establishments.
- Managers/executives (7.6% or 104,881) and supervisors/foremen (14.7% or 202,659) were also provided with job-related trainings.



Together, they comprised more than one-fifth (22.3%) of the total workers trained.

- In some industries, higher proportion of managers and executives were trained compared with other industries. This was in water recorded supply, sewerage, waste management and remediation services (19.2% or 3,165); financial and insurance activities (17.8% or 19,024); real estate activities (16.4% or 1,545); professional, scientific and technical activities (15.5% or 4,366); and electricity, gas, steam and conditioning supply (10.9% 5,167).
- Likewise, some industries allotted a larger part of their training to supervisors and foremen. This was most evident in information and communication (43.2% or 25,146); mining and quarrying (33.1% or 2,388); electricity, gas, steam and air conditioning supply (23.6% or 11,215); financial and insurance activities (22.3% or 23,841); and real estate activities (20.3% or 1,916).

Proportion of workers trained highest in medium-sized establishments

The proportion of workers trained in small-sized establishments with 20-99 workers (25.6%)was smaller than those posted medium-sized establishments with (33.9%)100-199 workers large-sized establishments with 200 workers (32.3%).more Meanwhile, corresponding the proportions for medium-sized and large-sized establishments were almost the same. (Table 4)

In-house training still a common practice among establishments

- More than two-thirds (68.8% or the total 15,759 10,850) of establishments that provided iob-related trainings to their workers in 2013 conducted the trainings themselves (in-house). (Table 5)
- Industry-wise, almost all establishments in electricity, gas, steam and air conditioning supply (97.3% or 220) conducted in-house trainings. High proportions were noted in other industries information particularly in communication (85.4% or 426); accommodation and food service activities (82.4% or 1,775); and private health and social work activities (81.0% or 389).

Four out of every nine establishments provided trainings through local private training institutions

- private The services of local training institutions were also considered essential by establishments. Based on the every survey, for nine establishments providing iobrelated trainings in 2013, four (44.3% or 6,978) got the services of these institutions for their HRD programs.
- High proportions of establishments that engaged the services of local private training institutions were most evident in electricity, gas, steam and air conditioning supply (68.1% or 154); private health and social work activities (67.5% or 324); and real estate activities (66.8% or 139).

Services of government training institutions availed of by more than one-fourth of the establishments

- Out of the total establishments providing job-related trainings, a little over one fourth (27.8% or 4,387) engaged the services of government training institutions.
- The proportion of establishments that hired the services government training institutions was most apparent in water supply, sewerage, waste management and remediation activities (80.4% or 168); electricity, gas, steam and air conditioning supply (75.7% or 171); and agriculture (57.7% or 310).

Only a small fraction of establishments availed the services of foreign training institutions

- During the period, only a small proportion of establishments (5.5% or 874) provided job-related trainings through foreign training institutions.
- Electricity, gas, steam and air conditioning supply was the only industry which reported a sizable proportion of establishments (36.3% or 82) that utilized the services of foreign training institutions.

Bulk of the total training cost spent for rank and file workers

Training cost for 2013 totaled ₱6,180 million. More than half (57.0% or ₱3,520 million) of this amount were used for rank and file employees. The rest were spent for supervisors/foremen (22.5% or

- Across industries, the highest proportion of training cost was observed in administrative and support service activities. Of the total ₱2,434 million training cost, 88.4% or ₱2,153 million were appropriated for rank and file workers.

Average training cost per worker at \$\frac{1}{2}4,482\$

- Establishments covered in this survey spent an average of ₱4,482 per worker trained in 2013. This figure varied widely across industry groups. Electricity, gas, steam and air conditioning supply spent the highest per capita training cost at ₱10,594. (Table 6)
- Other industries which posted training cost per worker higher than the average figure were: professional, scientific and technical activities (+8,711);administrative support and services activities (+8,252);information and communication education (+7,095);private (+6,592);and mining and quarrying (+6,394).
- The rest of the industries spent less than ₱3,000 per worker except financial and insurance activities as well as water supply, sewerage, waste management and remediation activities with average training cost per worker of ₱3,817 and ₱3,815, respectively. The lowest average training costs were noted in arts, entertainment and recreation (₱565), and agriculture, forestry and fishing (₱860).
