ABOR COST IN THE PHILIPPINES

Sixth of an eight-part series)



This LABSTAT is the sixth issue on a series of reports that focus on labor cost based on the results of the 2002/2003 BLES Integrated Survey (BITS) conducted last year in coordination with the DOLE Regional Offices. The BITS is a nationwide survey covering 6,818 sample non-agricultural establishments with 20 or more workers that aims to generate an integrated data set on employment, labor relations, labor cost and occupational safety in the workplace as basis for policy and program formulation.

This issue looks into the components of bonuses and gratuities across industries for the years 1998 (from the 1998 Labor Cost Survey) and 2002 (from the BITS). These are the 13<sup>th</sup> month pay, profit sharing bonuses and additional payments. Specific industry details can be accessed at the BLES Website.

## Annual Bonuses and Gratuities Per Employee Up by 58 % in 2002

Per employee bonuses and gratuities in 2002 stood at P19,147, higher by 57.6 percent than the P12,147 in 1998. It was highest in financial intermediation, estimated at P 45,836 in 1998 and P 69,339 in 2002, followed by electricity, gas and water supply recorded at P 39,600 in 1998 and P41,922 in 2002. It was, however, in hotels and restaurants where it almost tripled reaching P 15,125 in 2002 from P5,787 in 1998. (Table 1)

Across sub-components, year end, seasonal and other one -time bonuses such as 13th month pay was the highest at #11,059 in 1998 to <del>P</del>16,143 in 2002, posting a 46.0 percent increase. This type of bonuses accounted for the largest share to total per employee, 91.0 percent in 1998 but declining to 84.3 percent share in 2002. Additional payments to employees amounted to \$\mathbb{P}\$1,965 from only P241 per employee in 1998 while profit sharing reached P 1,039 in 2002 from <del>P</del>846 in 1998.

## Employees in Business Activities Received Highest Year-End and Similar Bonuses

Per employee year-end seasonal and one time bonuses of P42,446 was highest in financial intermediation in 2002. Second highest was P39,039 paid to workers in electricity, gas and water supply and P24,237 paid to those in transport, storage and communications. It was lowest in construction at P8,453.

The most substantial increase was noted in hotel and restaurants from \$\frac{1}{2}\$5,449 in 1998 to \$\frac{1}{2}\$14,920 per employee in 2002.

## Profit Sharing Bonuses Highest in Other Community, Social and Personal Service Activities

Estimated at P 3,161 per employee, annual profit sharing bonuses in other community, social and personal service activities was the highest in 2002. In financial intermediation, it was recorded at P2,718 and in manufacturing at P1,608.

To note, profit sharing bonuses increased only in manufacturing and other community, social and personal service activities over the four-year period.

## Highest Additional Payments Per Employee in Financial Intermediaries in 2002

From a mere \$\mathbb{P}\$351 in 1998, additional payments in respect of vacation, (supplementary to normal vacation pay) in financial intermediation increased to \$\mathbb{P}\$24,174 in 2002. This was followed by \$\mathbb{P}\$2,247 paid to each employee in electricity, gas and water supply and \$\mathbb{P}\$1,865 in other community, social and personal service activities.

Unlike profit sharing bonuses, additional payments increased across all industries.
