SUBJECT : Date of Effectivity of Administrative Order No. 2, Series of 2023, Implementing Rules and Regulations Governing Republic Act No. 11909 otherwise known as the Permanent Validity of the Certificates of Live Birth, Death, and Marriage Act

The Philippine Statistics Authority (PSA) recently issued Administrative Order No. 2, series of 2023 or the Implementing Rules and Regulations Governing Republic Act No. 11909 otherwise known as the Permanent Validity of the Certificates of Live Birth, Death, and Marriage Act.

Aligned with the policy of the State to establish an effective system for providing copies of civil registry documents to all its citizens and promoting efficiency and economy by removing duplicitous processes and requirements involving the issuance and use of those documents, the National Statistician and Civil Registrar General promulgated rules and regulations, in coordination with the Secretaries of the Department of Foreign Affairs (DFA) and the Department of Information and Communications Technology (DICT), and the President of the Philippine Association of Civil Registrars (PACR) that shall enforce the permanent validity of the certificates of live birth, death and marriage issued, signed, certified or authenticated by the PSA, and its predecessor, the National Statistics Office (NSO), the Local Civil Registry Office (LCRO), Shari'a Circuit/District Registrar, and the reports of birth, death, and marriage
