SUBJECT : Authorized Officials to Sign the Legal Capacity to Contract Marriage Issued in Cebu

DATE : 15 November 2018

Pursuant to Art. 21 of the Family Code of the Philippines that stated, "When either or both of the contracting parties are citizens of the foreign county, it shall be necessary for them before a marriage license can be obtained, to submit a certificate of legal capacity to contract marriage, issued by their respective diplomatic or consular officials. x x x".

Hence, the following diplomatic officials from the Consulate of the Republic of Korea are the authorized officials to sign a legal capacity to contract marriage issued in Cebu:

I am looking forward to your continued cooperation with the Consulate. Thank you.

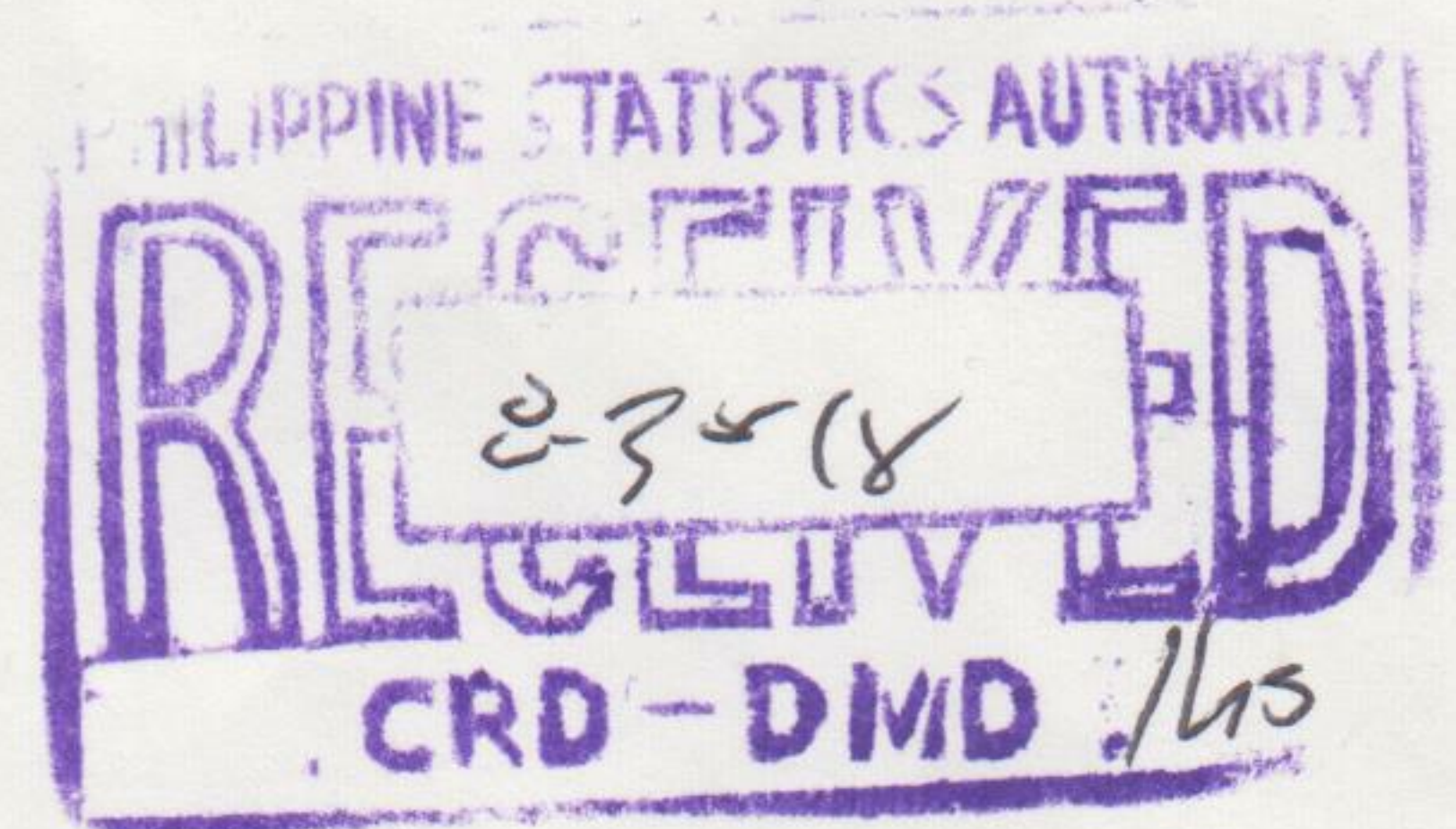
