Subject <u>2012 CIVIL REGISTRATION MONTH Celebration</u>

Pursuant to Proclamation No. 682, issued by former President Corazon C. Aquino on 28 January 1991, the month of February of each year has been declared as **Civil Registration Month.** This year's theme is **"Tamang Rehistro, Pananagutan ng Bawat Pilipino"**.

In line with this event, all NSO Field Offices (FOs) and Local Civil Registry Offices (LCROs) are enjoined to participate in this month-long celebration. The activities that you may undertake are:

1. MOBILE REGISTRATION

The City/Municipal Civil Registrar may initiate the adoption of an LGU resolution that will declare a day in February as Mobile Registration Week. The NSO Provincial Statistics Officers may coordinate with the Sangguniang Panlalawigan for the enactment of the said resolution.

2. DISPLAY OF STREAMERS

To create awareness of the event, putting up of streamers indicating the theme of the celebration in conspicuous place is recommended. For purposes of uniformity, attached is the standard design of the streamer marked as "Annex A".

3. FREE ISSUANCE OF CERTIFICATION

Free issuance of certifications has always been a part of the celebration. The LCROs may issue the certifications on February 23 to commemorate the National Birth Registration Day or February 27 to commemorate Civil Registration Day.

4. OTHER RELEVANT ACTIVITIES

Other activities which may be conducted by the LCROs are mass wedding, motorcade, symposium, information/education campaign, civil registration quiz, slogan contest, etc. These may be conducted as well to promote civil registration in the community.

A report on the activities that have been conducted in your locality in line with this year's celebration must be submitted to Ms. Lourdes J. Hufana, Director, Civil Registration Department.
