- ❖ Initiate collaboration projects with LGUs and other stakeholders to increase level of birth registration;
- ❖ Continue initiatives to conduct mobile registrations following the IATF and local restrictions;
- ❖ Review for streamlining processes and document requirements and adopt new technology in facilitating online registration;

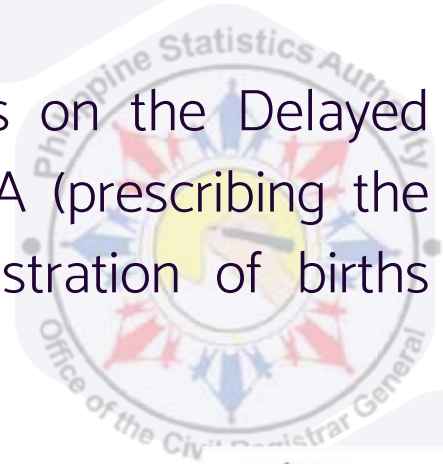

Birth Registration

- ❖ Conduct of inequality assessment for refugees and stateless persons and Ips; and
- ❖ Issuance of JMC on the Revised Guidelines on the Delayed Registration of Birth between DILG and PSA (prescribing the requirements and process of delayed registration of births including the standard fees for all LCROs).

Death Registration

- ❖ Intensify campaign on death registration and other civil registry documents through different platforms (regular radio programs, social media, CRVS webinars);
- ❖ Initiate special projects to address low level of registrations (Muslims, IPs/ICCs, and other marginalized sectors); and
- ❖ Improving quality of death statistics through capacity building (ICD 10, ANACONDA, IRIS, MCCOD and Verbal Autopsy).

Civil Registration Laws and Policy Issuances

- ❖ Continuous lobbying for the amendment of Civil Registry Law (Act No. 3753);
- ❖ Legislative amendment to expand effectivity of the CRASM from three years to five or 10 years; and
- ❖ Improve laws and policies related to civil registry to address security and data privacy concerns.

Philippine Identification System (PhilSys)

- ❖ Policy issuance for the specific guidelines on how to correct the different errors in the information in the National ID;
- ❖ Intensify registration campaign on PhilID in collaboration with the government agencies to accept to government and private transaction; and
- ❖ Develop Use-CASE PhilID validation for government and private sectors.
