MEMORANDUM CIRCULAR NO. 2023-002

Implementation of Cashless Payment for Local Government Unit (LGU) Batch Request System Transactions assigned to Transact with Civil Registry System Central Outlet



Cashless payment shall be strictly implemented to all LGU BREQS Partners whose designated servicing outlet is at the Civil Registry System (CRS) Central Outlet as enumerated in the table. CASH PAYMENTS for LGU BREQS shall not be accepted at the CRS CO starting 1 March 2023.

Remittance of payments can be made through Maya, Gcash, and bank-to-bank fund transfer transactions accredited by PSA

Aimed to serve as guide in the monitoring and processing of LGU Civil Registry Forms to prevent inexact Civil Registry Forms delivered, rejected Civil Registry Forms, damaged Civil Registry Forms, or other circumstances were not received by the intended LCRO recipient. Minimum Requirements for Late Registration of Birth Pursuant to the Implementation of the PhilSys Birth Registration Assistance Project (PBRAP)



06 February 2023

PBRAP – implemented to ensure that all births of Filipinos are registered in the Local Civil Registry Offices and that they will be enrolled with the Philippine Identification System.

Under this project, the requirements for late registration of birth were relaxed pursuant to the Operational Guidelines issued by PSA through Memorandum Circular No. 2022-15 dated 22 July 2022.





MEMORANDUM CIRCULAR NO. 2023-006

Minimum Requirements for Late Registration of Birth Pursuant to the Implementation of the PhilSys Birth Registration Assistance Project (PBRAP)



06 February 2023

Applicants are only required to submit the following documents as minimum requirements for late registration process:

- a) Negative Omnibus Certification issued by PSA;
- b) Accomplished Affidavit for Delayed Registration of Birth at the back of the Certificate of Live Birth;
- c) Affidavit of two (2) Disinterested Persons;
- d) Certificate of Indigency issued by the Punong Barangay; and
- e) Any proof of identity like Barangay Certification, Driver's License, among others, if applicable.

The requirements under Joint Memorandum Circular No. 2021-01 should only be complied in the ordinary process for delayed registration.

Processing of Copy Issuance of Civil Registry Documents and Certifications for Free as Pro Bono Transactions

24 May 2023



Free-of-charge replacement of issued civil registry document (CRD) at any Civil Registry System Outlet nationwide should the result of reverification of the issued CRD from PSA online channels such as psaserbilis.com.ph and psahelpline.ph and accredited BREQS partners is as follows:

- False issuance of negative certification while there is an existing record;
- Issuance of Advisory on Marriages/Deaths instead of a CENOMAR/CENODEATH or vice-versa

What to bring/present for replacement?

- Negative Certification/
 Advisory on Marriages/
 Deaths in Security Paper
 (SECPA)
- Official Receipt

Guidelines for the Registration of Death and Fetal Death

13 May 2023



Death - is defined as a permanent disappearance of all evidence of life at any time after live birth has taken place (postnatal cessation of vital functions without capability of resuscitation)

Fetal Death - is defined as the death prior to the complete expulsion of a product of conception, irrespective of the period of pregnancy.

Guidelines for the Registration of Death and Fetal Death

The following guidelines must be strictly adhered to on the registration of deaths and fetal deaths:

- 1. COD using Municipal Form No. 103 shall be prepared and to be registered in the Register of Deaths when the definition of death is satisfied and when the case are as follows:
 - a) A fetus with an intra-uterine life of seven months or more and born alive at the time it was completely delivered from the maternal womb but died; and
 - b) A fetus with an intra-uterine life of less than seven months and lived for more than twenty-four hours after its complete delivery from the mother's womb but died.

- 2. COFD using Municipal Form No. 103A shall be prepared and to be registered in the Registered of Fetal Deaths when:
 - a) Fetal Death occurred satisfying the stated definition.

If the fetus had an intra-uterine life of less than seven months, it is not deemed born if it dies within twenty-four hours after its complete delivery from the maternal womb, Therefore, a Certificate of Live Birth and Certificate of Death shall be prepared for statistical purposes only and should not be registered at the appropriate registry books.

3. Record organization

- a) Maintain separate registry books for both COD and COFD;
- b) Folio COD and COFD in separate folders; and
- c) Assign sequential registry numbers to each folio but for COFD, registry number will have a prefix of 6 e.g. Registry Number 2023-6000001, Registry Number 2023-6000002, and so on.

This amendment of the Implementing Rules and Regulations (IRR) of RA No. 9255 or AO No. 1 series of 2023 was published in the Official Gazette on June 5, 2023, a copy submitted to the UP Law Center on June 6, 2023.

AO No. 1 s. 2023 amended AO No. 1 s. 2016 to give retroactive effect for all births occurring within and outside the Philippines in accordance with Rule 1 of this Administrative Oder.

Section 1 Rule 1 of AO 1, s. 2023 is hereby amended as:

- "Rule 1. Coverage: These rules shall apply to all non-marital children during the effectivity of Executive Order No. 209 of otherwise known as the "Family Code of the Philippines." These includes:
- 1.1 Unregistered births; and
- 1.2 Registered births where the non-marital children use the surname of the mother

Section 2.

The rules and other prevailing issuances pursuant to RA No. 9255 shall have retroactive effect for all births occurring within and outside the Philippines in accordance with Rule 1 of this PSA AO No. 1-2023





MEMORANDUM CIRCULAR NO. 2023-15

Revocation of the Philippine Statistics Authority Issuances Allowing Local or Philippine Notarization of Affidavits in lieu of Certificates of Legal Capacity to Contract Marriage



13 May 2023

PSA hereby revokes the aforementioned issuances allowing local notarization of Affidavits in Lieu of Certificates of Legal Capacity to Contract Marriage

It is hereby required that the said affidavits/certifications be in the format prescribed and notarized directly by the diplomatic or consular officials of the concerned embassy.

Local Civil Registrars are directed to accept locally notarized Affidavits until 31 July 2023.





MEMORANDUM CIRCULAR NO. 2023-16

Extension for the Local Civil Registrars to Accept Locally Notarized Affidavits in lieu of Certificates of Legal Capacity to Contract Marriage

31 July 2023



Embassies of the United States of America, United Kingdom, Canada, and Australia in the Philippines requested for an extension of the acceptability of locally notarized Affidavits by the respective Local Civil Registrars.

Local Civil Registrars are directed to accept locally notarized Affidavits until 31 October 2023.





ADVISORY 23CRS02-07-971

Advance Endorsement through Electronic Endorsement Processing of Registered Civil Registry Documents at the Nearest Civil Registry System Outlet



18 August 2023

Electronic endorsement requests should be coursed through the nearest PSA Civil Registry System Outlets in accordance with existing protocols and timeline.

Electronic Endorsement Process is FREE OF CHARGE.
