**PSA Board Resolution No. 02
Series of 2021**

**APPROVING AND ADOPTING THE MODIFICATIONS
IN THE SYSTEM OF DESIGNATED STATISTICS**

WHEREAS, Executive Order (EO) No. 352 – *Designation of Statistical Activities That Will Generate Critical Data for Decision Making of the Government and the Private Sector* issued on 01 July 1996, established the System of Designated Statistics (SDS) in the Philippine Statistical System (PSS);

WHEREAS, per EO 352 and succeeding resolutions issued related to SDS, a total of 59 designated statistics and statistical activities are now being generated/implemented by 19 agencies under the PSS, as approved based on established criteria;

WHEREAS, the SDS is a dynamic process that allows continuous improvement/updating which involves pertinent modifications, addition of relevant activities, and deletion of activities that are no longer considered as priority to keep it attuned to the needs of data users;

WHEREAS, any modification on, addition to, or deletion from the list of designated statistics and statistical activities shall be approved by the PSA Board through a resolution in accordance with the implementing guidelines of EO 352 and succeeding resolutions on the modifications to the designated statistics/statistical activities;

WHEREAS, the Philippine Statistics Authority (PSA) has initiated efforts for the updating of its designated statistical activities;

WHEREAS, the PSA has proposed modifications in the SDS including changes/improvements in its designated statistics/statistical activities and designation/addition of statistical indicators;

WHEREAS, the proposed modifications involve the following:

A. Changes/improvements in PSA's designated statistics/statistical activities:

- 1) For Palay/Rice and Corn Stocks Survey
 - a) renaming of the designated statistical activity, from *Palay/Rice and Corn Stocks Survey* to *Rice and Corn Stocks Surveys* to provide a generic name for both household and commercial stocks surveys and differentiate the commercial stocks inventory from that in the household sector, specifically:
 - i. Household Stocks – from *Palay/Rice and Corn Stocks Survey Household Stocks* to *Rice and Corn Stocks Survey: Household*;
 - ii. Commercial Stocks – from *Palay/Rice and Corn Stocks Survey Commercial Stocks* to *Rice and Corn Stocks Survey: Commercial*
 - b) amending the implementing agency from *National Food Authority (NFA)* to *PSA for commercial stocks* per implementing Rules and Regulations (IRR) of Republic Act (RA) 11203
- 2) Splitting the *Palay and Corn Production Survey (PCPS)* into two designated statistical activities: *Palay Production Survey (PPS)* and *Corn Production Survey (CPS)* for consistency with PSA Board Resolution No. 3, s. 2020, "Approving and Adopting the New Sampling Design of the Palay Production Survey (PPS) and Corn Production Survey (CPS)"
- 3) Merging two designated statistical indicators, *Seasonally Adjusted Palay Production* and *Seasonally Adjusted Palay Prices* into one set of indicators, entitled, *Seasonally Adjusted Palay/Rice Production and Prices* carrying the schedule of release of 40 days after the reference quarter
- 4) Amending the schedule of release of *Monthly Integrated Survey of Selected Industries (MISSI)* from *45 days after the reference month* to *37 days after the reference month*;
- 5) Amending the monthly schedule of release of the *Generation of Foreign Trade Statistics (FTS)* from *45 days after the reference month* to *40 days after the reference month* except for the last month of every quarter as follows:

March, June, and September – 37 days after the reference month
December – 27 days after the reference month

B. Addition of indicators in the list of designated statistics:

- 1) Inclusion of the following derived indicators from the *MISSI* as new designated statistical indicators:
 - a) Value of Production Index (VaPI);
 - b) Volume of Production Index (VoPI);
 - c) Value of Net Sales Index (VaNSI);
 - d) Volume of Net Sales Index (VoNSI); and
 - e) Average Capacity Utilization Rate
- 2) Designation of *Producer Price Index (PPI) for Agriculture* which is a derived indicator generated from a designated statistical activity, *Farm Prices Survey (FPS)*

WHEREAS, the derived indicators generated from the *MISSI* and *FPS* are used in analyzing economic activities and formulating economic policies;

WHEREAS, the Interagency Committee on Agriculture and Fishery Statistics (IACAFS), Interagency Committee on Trade and Industry Statistics (IACTIS), and Interagency Committee on Price Statistics (IACPS) in coordination with the PSA, have reviewed the proposed modification of the aforementioned statistical activities and the proposed indicators for designation and found the proposals to be compliant with the criteria for modification of designated statistics per PSA Board Resolution No. 01, Series of 2017-90 – *Approving the Revised Guidelines on the Modification of Designated Statistics*;

WHEREAS, the IACAFS has endorsed to the PSA Board the approval of the modification of designated statistics/statistical activities of the PSA through IACAFS Resolution No. 01, Series of 2021 – *Endorsing the Modifications in the Palay/Rice and Corn Stocks Survey, Palay and Corn Production Survey, Seasonally Adjusted Palay Production, and Seasonally Adjusted Palay Prices*;

WHEREAS, the IACTIS has endorsed to the PSA Board the approval of the modification of designated statistical activities of the PSA and the addition of derived indicators from *MISSI* in the SDS through IACTIS Resolution No. 01, Series of 2021 – *Endorsing the Modifications in the System of Designated Statistics, Particularly on Monthly Integrated Survey of Selected Industries and Foreign Trade Statistics, to the PSA Board for Approval*;

WHEREAS, the IACPS has endorsed to the PSA Board the approval of the addition of *Producer Price Index for Agriculture* in the SDS through IACPS Resolution No. 01, Series of 2021 – *Endorsing the Modifications in the System of Designated Statistics, Particularly Farm Prices Survey, to the PSA Board for Approval*;

WHEREAS, after review and evaluation, the PSA is recommending for approval of the Board the proposed SDS modifications;
