**PSA Board Resolution No. 05
Series of 2016**

**APPROVING AND ADOPTING THE
2016 PHILIPPINE TOURISM STATISTICAL CLASSIFICATION SYSTEM**

WHEREAS, tourism has a significant role and impact on the social and economic development of the country;

WHEREAS, tourism is integrated in various economic sectors and thus needs to have a standard classification that will identify the tourism products and activities;

WHEREAS, the first Philippine Tourism Statistical Classification System (PTSCS) was formulated by the Interagency Committee on Tourism Statistics (IACTS) and approved in 2005 by the then National Statistical Coordination Board (NSCB) through NSCB Resolution No. 04, series of 2005 based on the United Nations World Tourism Organization (UNWTO) recommended lists of tourism characteristic activities, products and durable goods, the 1994 Philippine Standard Industrial Classification (PSIC), and the 2002 Philippine Central Product Classification (PCPC);

WHEREAS, updating of the tourism classification is one of the major activities in the Chapter on Tourism Statistics of the 2011-2017 Philippine Statistical Development Program (PSDP);

WHEREAS, the UNWTO has issued the International Recommendations for Tourism Statistics (IRTS) 2008 which provides the main concepts, definitions and classifications for the measurement of tourism in a standard way among countries;


WHEREAS, the Philippine Statistics Authority (PSA) and Department of Tourism (DOT) have updated the 2005 PTSCS based on IRTS 2008 and existing classifications in the country, such as the 2009 PSIC and 2002 PCPC;

WHEREAS, the IACTS during its meeting on 14 April 2016 reviewed and evaluated the proposed 2016 Philippine Tourism Statistical Classification System and provided recommendations which were incorporated in the classification;

WHEREAS, the IACTS is endorsing the said classification for approval by the PSA Board through IACTS Resolution No. 01, series of 2016;


