- Scanned copy of signed WORK EXPERIENCE SHEET (CSC Form No. 212

   as Attachment to PDS);
- 4. Scanned copy of **AUTHENTICATED ELIGIBILITY** (CSC, RA 1080, PD 907, etc.);
- Scanned copy of TRANSCRIPT OF RECORDS;
- 6. Scanned copy of **CERTIFICATE/S OF TRAINING** participated within the last five (5) years relevant to the position applied for (if applicable); and
- 7. Scanned copy of **CERTIFICATE/S OF WORK EXPERIENCE** relevant to the position (for applicants with work experience).
