3/ Excludes basic and industrial chemicals, animal and vegetable oils and fats, fertilizers and limes, crude dye stuffs and tanning extracts.

4/ Excludes leather & leather manufactures, other than rubber & related products, other wood, cane & cork products, pulp paper & paperboard containers, abaca, clay products, primary metals.

5/ Excludes agricultural machinery and equipment.
